One condition of sale is that the site be used or cleared within a two year period of time Porter asked how the City came to acquire the property

and Patterson said it was because of the 3rd St. underpass project. When the underpass was built we eliminated access to the building. Olcott asked where the monies from the sale would go and Patterson replied the Local Road and Street Fund and would be used for any capital street project.
