Council President Regester gave the agenda summation.

AGENDA SUMMATION

The minutes of November 19, 1986 were approved by a voice vote.

APPROVAL OF MINUTES

Service commented on the dismantled Shantytown and hoped people would not forget what it stood for and the fact that the I.U. administration still supports the concept of apartheid by their investment policies toward South Africa. She also expressed dissatisfaction with the County's "go-it-alone" approach to the parks programs.

MESSAGES FROM
COUNCILMEMBERS

Gross also expressed concern about the County park issue and one criticism might be understandable. The budget indicates a parks budget that is top heavy with administration. Gross said this is a concern that she has expressed at several budget hearing meetings and what we are now seeing is the disintegration of our pay structure. Our personnel must be titled and paid fairly.

It was moved, seconded and approved by a voice vote that David Twomey be appointed to the Environmental Commission replacing Leo Thorbecke. Twomey's term will expire in January 1989.




