In the Council Chambers of the Municipal Building held on Wednesday, August 21, 1985, at 7:30 P.M. with Council President Gross presiding over a Regular Session of the AUGUST 21,1985 Common Council.

COMMON COUNCIL REGULAR SESSION

Roll Call: Service, Porter, Regester, Olcott, Gross, Mayer, ROLL CALL Murphy, Foley, Young.

Gross gave the agenda summation.

AGENDA SUMMATION

There were no messages from councilmembers.

MESSAGES FROM COUNCILMEMBERS

There was no Mayoral message.

MESSAGES FROM THE MAYOR

Ron Foley introduced Ben Waxler, Secretary of the REPORTS FROM Bloomington Human Rights Commission, and Waxler presented a COMMITTEES resolution that the Commission passed unanimously at their last meeting. The resolution asked the City of Bloomington to examine it's own investments and the investments of the companies that do business with the City. Waxler said that the resolution was certainly within the jurisdiction of the Human Rights Commission as that commission does concern itself with conditions within the city, reviews contracts for correct contract compliance and does feel that it should project a moral voice for the community.

Chris Gardner, also a member of the Human Rights Commission, said that several U.S. cities have already adopted similiar resolutions. The Commission recognizes that this is a very sophisticated problem, that this resolution attempts to identify the problem and that this is just a first step in attempting to solve the problem. Gardner said that it was time that Bloomington adopted such a policy, noting that the Dante Inferno quote regarding the hottest place in hell is reserved for those who in time of moral crisis, remain neutral.

Foley, as a former Human Rights Commissioner, applauded the Commission for the bold resolution on this timely issue and hoped that the City would take it under serious advisement.

Service also thought this was a very timely resolution and was pleased that we as a City were taking this first step. Murphy agreed with his colleagues and said that we should continue to speak out.

Gross suggested a committee consisting of councilmembers, and the Controller to discuss how investments are made. Murphy, Service, Foley and Mayer volunteered and Gross said that an announcement would be made two weeks from tonight about the actual format of the committee.

The minutes of July 31, August 7, and August 14, 1985 were APPROVAL OF approved by a voice vote. MINUTES

SECOND READING

APP. ORD 85-4 1986 CIVIL CITY

Olcott moved and Foley seconded a motion that Appropriation BUDGET Ordinance 85-4 be adopted. Gross gave the ordinance synopsis.

It was moved and seconded that the following ordinance be considered: That Appropriation Ordinance 85-4 shall be amended to reduce the General Fund/Telecommunications Budget by \$10,000 (Line 396) and \$1,500 (Line 323). Service wondered if the new cable franchise agrees to the additional access channel and do we still need this amendment. Regester said the additional channel was still in the developmental stage and it hardly seemed wise to make such a substantial allocation at this time.

Iris Kiesling said she was sorry the Council was making this cut and she urged TCI to activate the channel as soon as possible.

The amendment received a roll call vote of Ayes:8, Nays:1 (Service).

Service then moved that the Council salary raise be the 6% and that the 12% recently approved be deleted from the budget line in the Common Council budget.

Murphy said that motion was uncalled for and he would not support it.

The motion was defeated by a roll call vote of Ayes: 1, (Service) Nays: 8.

The ordinance, as amended, received a roll call vote of Ayes: 9, Nays: 0.

Olcott moved and Foley seconded a motion that Appropriation APP. ORD 85-5 Ordinance 85-5 be introduced and read by title only. Clerk Williams read the ordinance by title only.

Olcott moved and Foley seconded a motion to adopt Appropriation Ordinance 85-5. Gross gave the synopsis.

Greg Moore asked about attornies fees for PCB litigation. Gross said the USB was authorized to fund attorney services.

The ordinance received a roll call vote of Ayes: 8, Nays:1 (Service).

Olcott moved and Foley seconded a motion that Ordinance $$\circ \epsilon \delta$.85-41$ 85-41 be introduced and read by title only. Clerk Williams read the ordinance by title only.

Olcott moved and Foley seconded a motion that Ordinance 85-41 be adopted. Gross gave the synopsis.

There was no discussion and the ordinance received a roll call vote of Ayes: 9, Nays: 0.

ORD. 85-42

Olcott moved and Foley seconded a motion that Ordinance 85-42 be adopted. Herb Terry commented on the emergency override procedure and said that in no way shoud it override the local media emergency message.

The ordinance received a roll call vote of Ayes:9, Nays: 0.

Olcott moved and Foley seconded a motion that Resolution RES. 85-32 be introduced and read by title only. Clerk Williams read the resolution by title only.

Olcott moved and Foley seconded a motion that Resolution 85-32 be adopted. There was no committee report.

Peggy Gudal said that this was a request for 30 units and Gene Stokes said that we are the only city in Indiana that has this Section 8 housing.

The resolution received a roll call vote of Ayes: 9, Nays: 0.

TO URGE THE CITY OF BLOOMINGTON AND ALL OTHER
INSTITUTIONS AND BUSINESSES TO DIVEST THEMSELVES
OF HOLDINGS IN AND TO DISCONTINUE DOING BUSINESS
WITH CORPORATION WITH INTERESTS IN SOUTH AFRICA.

- WHEREAS, the economic, social and political system of South
 Africa officially incorporates Apartheid, a doctrine of
 racial separation under which rights and obligations of
 individuals are defined according to their race; and
- WHEREAS, the principles of Apartheid run counter to the beliefs generally held in the United States and the City of Bloomington supporting human rights, civil liberties and equality of opportunity; and
- WHEREAS, the Bloomington Human Rights Commission requests that the City of Bloomington as a first step in this process, determine all of its investments and activities in South Africa or with companies with interests in South Africa and discontinue the same immediately.
- WHEREAS, the Bloomington Human Rights Commission further requests that as a second step in this process the Common Council of the City of Bloomington with the Bloomington Human Rights Commission adopt rules and regulations which would require all businesses involved in bidding or transactions with the City of Bloomington to divulge to the City of Bloomington all of their investments and/or activities in South Africa or with companies with interests in South Africa.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE HUMAN RIGHTS COMMISSION OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

- 1. The Human Rights Commission commends the Common Council on resolution 85-17.
- The Human Rights Commission urges all Bloomington institutions and businesses to divest themselves of investments and to discontinue doing business with companies with interests in South Africa immediately.
