President Gross asked for nominations for Council Liason to the Plan Commission. Councilmember Service nominated Councilmember Murphy. Porter seconded. The vote was unanimous.

President Gross asked for nominations to the Utilities Service Board. Councilmember Mayer nominated Foley; Porter seconded. The vote was unanimous.

President Gross announced that the first regular Council meeting would be held Wednesday, January 4, at 7:30 PM in the Council Chambers.

Councilmember Murphy moved to adjourn; Regester seconded.
