ROLL CALL

Council President Gross gave the agenda summation.

AGENDA SUMMATION

Olcott stated disappointment that the State Department of Corrections has gone ahead, despite community objections, and located the Work Release Center on the Old Packinghouse site. The previous council had supported the concept of work release and this unilateral decision is particularly disturbing. The state has been hasty in their decision.

MESSAGES FROM
COUNCILMEMBERS

Foley commended Ray Brown, president of the Bloomington Township Firefighters Association, for the generous donation of \$1000. to the Community Kitchen. Foley also agreed with Olcott's remarks regarding the placement of the Work Release Center. He said that State Corrections Department should have come into the community and worked with the community leaders. He continued by saying this center is affecting a quality of life in this community and that all elected officials should come together and work for a site that is agreeable to all members of the community.

Gross announced the various vacancies on Boards and Commissions and urged citizens who were interested to apply for the positions. Due to recent changes in Title 2, a number of terms are expiring on January 31 of this year. All persons have been notified regarding term dates and invited to reapply.

Gross announced that James Register would be the Council's appointment to the Monroe County Economic Development Commission. Gross also announced that Lloyd Olcott would be the Council's representative on the Joint Interlocal Park Board.
