In the Council Chambers of the Municipal Building held on Wednesday, January 18, 1984, at 7:30 P.M. with Council President Gross presiding over a Regular Session of the Common Council.

Councilmembers present: Service, Porter, Register, Olcott, Gross, Mayer, Foley, Murphy. Absent: Young (vacation).

Council President Gross gave the Agenda Summation.

Service commented on the Bloomington Monopoly Game. After contact with an acquaintance the fact came to light that the organization used a guide from the 1940s to compile the various statistical information about Bloomington. (This is a Monopoly type game using various Bloomington merchants and institutions as subjects and the cover piece that accompanies the game contains several factual errors regarding Bloomington).

Mayer thanked the street crews for their excellent job of attending the streets during the heavy morning snow.

Gross congratulated Service on her appointment as the Monroe County Historian.

Murphy asked Olcott under penalty of subpoena 'who is Horace Moses'? Olcott replied that in August of 1984 a twenty-five cent commemorative stamp will be issued by the post office honoring this famous Bloomingtonian. Mr. Moses was the founder of the Junior Achievement program that takes place every summer here in Bloomington. Murphy expressed relief that this pressing question had finally been answered.

There was no Mayoral message.

There were no petitions or communications from the public.

Olcott moved and Service seconded a motion that Ordinance 84-1 be introduced and read by title only. Clerk Williams read the ordinance by title only.

Service said that she resented the university putting the city over a barrel on this issue and hoped that they will be more sensitive to what kind of development they put in that area. "It is not fair to have them dictate a lot of things not directly related to the university".
