In the Common Council Chambers of the Municipal Building held on April 6, 1983, at 7:30 P.M. with Council President Kathy Dilcher presiding over a Regular Session of the Common Council.

Councilmembers present: Towell, Porter, Service, Dilcher, Murphy, Gross, Hogan. Absent: Morrison, Olcott.

Council President Dilcher gave the agenda summation.

Gross thanked Workable Programs chairman Bruce Houghtelin and his committee for their many hours devoted to the Community Development COUNCILMEMBERS Fund resolution. She also expressed concern about the Griffy Lake plans and the decisions that neglected citizen input and concerns. The experiment will not work without the good will of all citizens and while the boats may be allright, she was sorry that the decision was not revoked.

Towell agreed with Gross, saying the problem was not necessarily just the boats, but that a large part of the concern was that no attention had been given to the erosion problems in the area. He suggested a city employee, similar to the cemetery staff, be present in the area to study the ecological nature of the area. The polarization of citizens was an unpolitic way of handling the situation. He proposed a year of study and negotiation.

#### There was no Mayoral message.

Don Agostino, Chairman of the Telecommunication Council, presented the Council's workplan for the refranchise/renewal of the cable contract. He stressed the need for the community to be brought into the process by way of public forums and demonstrations, engineering studies, education of the public as to what is available and to determine what people are willing to pay for expanded cable television. The cost of the process will be determined by the number of filing fees. \$15,000-20,000 is a typical amount for a fee.

Hogan asked if competitive cable companies could co-exist in the same community and has it been successful elsewhere. Agostino said that arrangment was possible, by law, but not at all successful.

Towell asked Agostino if he thought the citizens of Monroe County were well served by the present franchise. Agostino thought there could be improvements in service and costs; "Bloomington gets a little lost in a 400 plus system".

Murphy asked about the recent addition of the Disney channel. Agostino said that of the seven types of available cable expansion, the children's channel was in least demand.

Dilcher inquired as to the problem of 'adequate service'. Does the council have to refranchise with the present company if another company is 'better'. Agostino said he hoped the Council would be confident of the Telecommunications Council's experience and knowledge regarding franchising and that much would depend upon the response at the time of actual refrachising. Dilcher thanked Agostino and the Council, expressing appreciation for the time and effort this process will take now and in the future. We are very fortunate to have it all right here.

The council approved the workplan by an unanimous voice vote.

Sam Hays, owner of a car that was towed over spring break, petitioned the Council for payment of the \$45 towing and storage fees. He said the city had blundered. The difference in local tow and storage charges was unethical.

Ann Vaughan said that any citizen can file a claim with the City's insurance company and/or file in small claims court.

Service moved and Murphy seconded a motion to introduce and read Ordinance 83-13 by title only. Clerk Williams read the ordinance by title only.

Service moved and Murphy seconded a motion to adopt Ordinance 83-13. Dilcher read the legislative synopsis and Porter gave the committee report.

Towell requested ordinance models from other communities at the committee meeting. He felt that our ordinance could be improved, the original being somewhat primitive. Recent events in other cities indicate some improvement to be necessary.

Hogan expressed concern that the appeal time was insufficient; if a parade permit were denied then the Council would have to act upon the appeal immediately.

The amendment was amended to cause the Council to act upon the appeal within (5) days after its receipt.

The amendment received a roll call vote of Ayes: 7, Nays: 0.

The ordinance as amended received a roll call vote of Ayes: 7, Nays: 0.

Service moved and Murphy seconded a motion to introduce and read RESL 83-14 Resolution 83-14 by title only. Clerk Williams read the resolution CDBG BLOCK GRANTS by title only. Dilcher read the legislative synopsis and Porter gave the committee report.

Hogan's objections to the resolution centered around two points. Funding the Dental Care Program and the Downtown Economic Development Program. The Dental Care Center is injurious to local dentists; there is a long wait for appointments for routine dental care; does not provide care in crisis situations; and is often more costly than a private practice dentist. The economic development of a city should be the major responsibility of the Mayor and not someone else. Because of these two items Hogan could not support the resolution.

Murphy suggested voting on each appropriation.

Service said that many programs are inadequate to meet the real needs of a community but that should not stop a city from trying.

Hogan suggested a budget hearing format for CDBG funds, that problems cannot be solved by throwing dollars at them. At budget time the council spends hours dissecting each item and just such careful consideration should be given these monies even if it is federal monies.

Murphy said that the Workable Programs hearing goes on for months and the Dental Care Program and the Domestic Violence Service are two of the finest examples of a city's concern for its citizens. Gross said the advantage of the Workable Programs committee was the size of the group and the largeness of the group was an advantage over the relatively small Common Council input that could be exerted if the Council made the recommedations.

Service stated that in the past the entire CDBG program was the responsibility of the Council. This process involved many hearings and many problems and was not particularly satisfactory. It was almost impossible for nine councilmembers to amass the necessary information to determine the needs for an entire community. She suggested interested councilmembers attend the workable program meetings if they were interested in total participation.

The resolution received a roll call vote of Ayes: 6, Nays: 1 (Hogan).
