In a meeting held in the Council Chambers of the Municipal Bldg., COMMON COUNCIL November 2, 1983, 7:30 P.M., with Council President Dilcher presiding over a Regular Session of the Common Council.

Councilmembers present: Porter, Towell, Service, Dilcher, Murphy, Olcott, Gross, Hogan. Absent: Morrison.

Council President Dilcher gave the agenda summation.

Olcott wished all his cohorts the best of luck in next Tuesday's MESSAGES FROM election.

Murphy said that it has been a real honour and privilege to know and serve with everyone on the council; regardless of the rhetoric he considered everyone his friend.

Service congratulated the Arts Commission and the Parks and Recreation Department for successfully completing the arrangements for the R.R. underpass murals. Service also reitereated Mayor Allison's statement regarding leaf pick-up, asking people to wait until after the first frost to rake their leaves to the curbside. Doing it ahead of time only clogs the sewers and city drains when we experience fall rains and if the pick-up schedule begins too early then the whole purpose of the project is defeated if all the leaves are not down.

There was no Mayoral Message.

Bill Van Hook, speaking on behalf of Gladys VanHook an employee of the Legal Department, said that Gladys is being harrassed and is the only employee to suffer a cut in salary next year. He wished to inform the Council that action has been filed. He suggested that the Council investigate the legal department. He said the Gladys has made a 'career' of service to the City and should be rewarded, not have her salary cut.

David Shleibaum suggested an education program or workshop be held regarding zoning and ordinance changes as they pertain to the Monroe County Homebuilders Association. He felt that this would be helpful and beneficial for everyone.

Dilcher said that the Council would appoint a councilmember to work on this committee but suggested waiting until after the elections. Shleibaum said that it would be best to try and include the Council, the Plan Commission, and the County Council and Plan Commission.

Olcott moved and Towell seconded a motion to introduce and read Ordinance 83-56 by title only. Clerk Williams read the ordinance by title only.

Olcott moved and Towell seconded a motion to adopt Ordinance 83-56. Hogan gave the committee report.

Jim Dorr represented the Traffic Commission. Gross asked why the cleaning establishment on S. Walnut was requesting the change in parking when they already have several two hour parking spaces. Dorr said that during the day customer activity is heavy and the loading and unloading designation is more appropriate.

Olcott asked why not a 15 minute parking designation and Dorr said that is almost impossible to enforce.

The ordinance received a roll call vote of Ayes:8, Nays:0.
