COMMON COUNCIL REGULAR SESSION MAY 5, 1982.

Councilmembers present: Morrison, Towell, Porter, Allison Murphy, Dilcher, Olcott, Service.
Absent: Hogan.

ROLL CALL

Council President Murphy read the agenda summation.

AGENDA SUMMATION

Service reminded the Council that this was Be Kind to MES Animals Week and commended the Animal Shelter for the excellent COU job that they have done for the community. On a sad note, just last year 3,000 animals were euthanized at the Bloomington Animal Shelter and people must be made more aware of their responsibilities as pet owners to have their animals spayed and neutered.

MESSAGES FROM COUNCILMEMBERS

Service also read a letter from a group of downtown merchants praising the parking meter ordinance and urging the Council to continue the no-fee two hour parking. All of the merchants agreed that this was a wonderful boost for the downtown area.

Olcott praised Allison for her efforts on behalf of Operation City Beautiful and pledged the Council's support and appreciation for her leadership and hard work in making Bloomington a better place to live.

Allison thanked Geri Wells, of the Human Resources Department, for the very successful plant exchange on May 1, 1982. The event was held in the parking lot of the Municipal Building and enjoyed by everyone who attended.

Allison also encouraged participation in the Old Library Landscaping Committee. The group will meet on May 14, 1982 at 4:00 P.M. at the Old Library.

Towell said in reference to the Animal Shelter comments, that in the past, five hundred animals were euthanized each month and we should be somewhat endouraged that the numbers are decreasing.

Murphy praised the Bloomington Fire and Police Departments for their excellent performance during the Bloomington Hospital fire. The removal of patients was carried out in an orderly and efficient manner and it was to the credit of all involved that not a single injury to a patient was reported. Murphy also commended Police Officers Pickell and Helms for their roles in an early morning traffic incident. Thanks to their immediate response a potential tragedy was averted.

Olcott moved and Morrison seconded a motion to introduce and read Ordinance 82-21 by title only. Clerk Williams read the ordinance by title only.

Olcott moved and Towell seconded a motion to amend the ordinance by making a change in Section I. The definition of "Lodginghouse Roominghouse" should be amended to read "five unrelated adult individuals."

Olcott moved and Morrison seconded a motion to adopt the amendment.

Towell said that the public sentiment toward amusement machines was largely negative. He said that the number of parking spaces is rather high.

Service said that she would oppose this ordinance and that care should be taken to prevent this area from becoming a commercial strip.

Morrison asked Tim Mueller if this issue was covered by the entrance corridor ordinance. Mueller said that billboards, landscape screens, setbacks, and esthetics were covered in that ordinance but not land use.

The ordinance received a roll call vote of Ayes: 7, Nays: 1 (Service).

Olcott moved and Morrison seconded a motion to introduce and read Ordinance 82-30 by title only. Clerk Williams read the ordinance by title only.

Olcott moved and Morrison seconded a motion to adopt Ordinance 82-30. Olcott read the legislative synopsis.

Towell said that he had originally abstained for reasons of allowing more thought to this particular rezoning, and after careful consideration sees no problem with this rezoning. Towell did say he was concerned with a domino effect on the area in general once this ordinance was passed.

Olcott said that Dr. Haddawi is the first domino on that side of the street. We are building a large regional hospital that will attract more and more doctors who will need to be near the hospital area.

Morrison said that he was very happy to have Dr. Haddawi utilizing that area, that many of the homes are old and not in the best repair and Dr. Haddawi will be a welcome

Towell said he was glad this was finally being taken care of and that he was in favor of paying legal debts.

Allison said that this was just the beginning of more and more payments for landfill use.

Murphy said that the City-County Committee had been meeting for some time and that the city had gone out of their way to cooperate with the fee system for sanitation fees.

John Freeman, Director of Public Works, said that the cost will continue to rise perhaps as much as \$12,000 to \$14,000 more in 1983. If the cost continues to escalate the city will be forced to look into a facility of their own.

Olcott inquired as to what point we make this decision.

Service said that the city has been treated unfairly and that it will not be easy to find another landfill site.

Porter said that landfill will not be the solution, that other means of trash disposal will have to be solved by means of a different technology.
