Service announced the National Certification of the Animal Shelter and commended the personnel at the shelter for their fine job in serving the public.

MESSAGES FROM
COUNCILMEMBERS

The North Washington Street area has now been placed on the National Register of Historic Places.

The Town Theatre production of The Mikado will be this weekend.

Olcott congratulated Bloomington for its good sense and judgment in sending our very fine mayor to Washington as our congressman and he congratulated Frank on a race well run.

Dilcher also congratulated the Mayor upon his election to Congress.

Allison extended her congratulations and said that Mr. McCloskey was a politician in the very best sense of the word. "He's done a good job and earned his place as a congressman." Allison reminded the public that leaf pick-up begins Nov. 15 and that leaves should be piled on the grassy areas and not in the curbs. The Old Library Project has been completed and Steve Wajda and Rosemary Miller are to be commended for their interest and support in the project.

Towell said that he was proud that Frank McCloskey won the congressional seat. He also announced that Harriet Lipkin, Deputy City Attorney will present a case before the U.S. Supreme Court and wished her well in her pursuit.

Morrison also congratulated Frank and talked about his years on the council and Frank's years as Mayor.

Murphy, last but not least, extended his best wishes to the Mayor and then offered the podium to the Mayor and Congressman-Elect.

Frank McCloskey addressed the Council and all those present and tried to express what his eleven years as Mayor of Bloomington had meant to him. Controlling himself with some difficulty, he warmly talked about his ambivalent feelings about leaving Bloomington and moving to Washington. "Bloomington is just about the best place in the universe", he said, and from the standing ovation and warm response it seemed that everyone present was very proud and happy for Frank McCloskey.


