In the Common Council Chambers of the Municipal Building held on December 15, 1982, with Council President Pat Murphy presiding over a Regular Session of the Common Council.

DECEMBER 15, 1982

Councilmembers present: Morrison, Towell, Porter, Allison, Murphy, Dilcher, Olcott, Service, Hogan.

Council President Murphy gave the agenda summation.

Service announced that the Council Chamber walls are available for the display of local art works. Contact Tom Coleman or Regina Miller for details.

MESSAGES FROM COUNCILMEMBERS

Olcott congratulated Coach Jerry Yeagley and the NCAA title won by the I.U. Soccer team. Olcott asked that an encomiun be prepared honoring Coach Yeagley.

Allison thanked Jeff Fanyo for his services as City Engineer and wished him well in his future professional pursuits. Allison expressed concern regarding the large numbers of registered voters receiving purge letters. Government must be very careful to protect the right and privilege to vote.

Towell responded to Allison's remarks and concurred with them.

Murphy wished everyone a Merry Christmas.

There was no Mayoral message.

Olcott moved and Morrison seconded a motion to introduce and read Ordinance 82-74 by title only.

Clerk Williams read the ordinance by title only.

Olcott moved and Morrison seconded a motion to adopt Ordinance 82-74. Service read the committee report.

Sidewalks, easements were granted and the correct water line size as indicated by the Public Works was agreed upon.

The ordinance received a roll call vote of Ayes: 9, Nays: 0.

Olcott moved and Morrison seconded a motion to introduce and read Ordinance 82-75 by title only.

Clerk Williams read the ordinance by title only.

Olcott moved and Morrison seconded a motion to adopt Ordinance 82-75. Service read the committee report.

Frank Ragan explained the reduction in the appropriation amount and was hopeful that the council would not mind a reduced request as presented in the amendment before the council.

The amendment received a roll call vote of Ayes:9, Nays:0.

Towell asked about the large expenditure at the end of the year for new radios.

Officer Clendenning said that the portable radios are ten years old, have been serviced frequently and are just wearing out. As a radio is the first line of defense it seems more prudent to replace them, than to operate with inferior equipment.

Frank Ragan said that in order to streamline the golf course operation it has become necessary to have someone at the site, full-time, to take charge and to resolve problems that come up.

Clerk Williams read the resolution by title only.

Olcott said that Mr. McClure would soon be leaving the Utility Department. He said that it has been a very tough position to be in for the last five years and he felt that McClure had done a first class job for the city.

Allison said that she appreciated the management techniques that he had brought to the utility department.

Hogan thanked McClure and said that it had been a pleasure working with him. Towell said that McClure had been particularly responsive to council concerns.

3. That the following paragraph designated (a) be added to Section 15.32.050 Parking During Snow Removal, Street Repair and Street Cleaning as follows:

All on street parking shall be prohibited between the hours of 3:30 a.m. and 6:30 a.m. in the downtown area bounded by Seventh Street on the North, Morton Street on the West, Second Street on the South and Washington Street on the East.

Olcott said that the amendment could be changed if it was not workable.

The amendment received a roll call vote of Ayes:8, Nays:1 (Murphy).

4. That Ordinance 82-76 be amended to add, as a Class C Violation, the following section:

# 15.20.010 Restricted Turn Intersections

The amendment received a roll call vote of Ayes:9, Nays:0

5. That Ordinance 82-76 be amended to change from a Class E violation to a Class C violation the following:

That the penalty provision be changed to a Class C (\$50 fine) from a Class E (\$3).

Ann Vaughan said that fines established by code and in real situations the offender doesn't often pay the full fine.

Olcott moved and Morrison seconded a motion to introduce and read Ordinance 82-78 by title only.

ORD. 82-78 TO ESTABLISH COUNCILMANIC DISTRICTS FOR THE CITY

Clerk Williams read the ordinance by title only.

Olcott moved and Morrison seconded a motion to adopt Ordinance 82-78. Service read the committee report.

In response to several plans presented, Towell presented an amendment. A copy is attached to the official minutes.

Morrison said that prior to his becoming a councilmember no one really represented the west side or cared about it. The people who live in Bloomington 2 and 3 are the people who got the federal funds for the area; no one living in Perry 14 or Van Buren 2 could really care about that district.

Hogan said that a committee had been formed and proposed a plan. He agreed with that original proposal.

Morrison said that his district was heavily democratic and still he was re-elected. He said that no one from Perry 14 could be elected. He said that people want good representation.

Towell agreed with Morrison.

Hogan expressed concern that incumbants would not actually be representing the constituents that elected them in the first place. Dilcher said that this would not be effective until November of 1983.

Towell said that at one time Perry 1 and 14 were one and that Bloomington 17 has also been in that district.

Morrison said that the west side knows that you cannot depend on a political party, just the person representing it and that he would campaign actively.

Towell said that the west side was favored by this plan and that the west side is still very much intact.

The ordinance received a roll call vote of Ayes:5, Nays: 4. (Porter, Olcott, Morrison, Hogan).

Olcott moved and Morrison seconded a motion to introduce and read the following ordinances for first reading by title only.
