In the Common Council Chambers of the Municipal Building, held March 4, 1981, with Councilpresident Towell presiding over a regular session of the Common Council.

Councilmembers present: Allison, Towell, Olcott, Morrison, Murphy, Porter, Hogan, Dilcher and Service.
Councilmembers absent: None.

Councilpresident Towell read the agenda summation.

Murphy said he had the unfortunate experience of riding on a City bus when it broke down recently. He said the transit system needs a lot of work done in the promotion area, and said that if the department can't be run in a satisfactory manner then busses should perhaps be done away with.

Service said that she recently had a fire in her basement furnace and the Fire Department responded very quickly and effectively. A major fire may have been averted since the Housing Code Office had required that old rags and boxes be removed from the furnace area, and she's now glad that they did.

Hogan said the reception for the opening of B.F. Goodrich was very pleasant as was the Kittle's opening. He welcomed them both to the community.

Towell said that the Council's Cable TV Seminar was very successful yesterday evening, with many city and county elected officials present, and excellent information was presented and discussed.

There was no Message from the Mayor.

There were no Petitions or Communications.

Olcott moved and Morrison seconded a motion to introduce and read Resolution 81-6 by title only.

Clerk Connors read Resolution 81-6 by title only.

Olcott moved and Morrison seconded a motion to adopt Resolution 81-6.

Porter read the legislative synopsis and gave the committee report with a Do Pass recommendation of 8-0-1.

Len Bunger, attorney for the hospital, said that they have contacted Mr. Stein, Vice President of the Corporation that owns the land. He is interested in further negotiation, but this will not affect this resolution. They want to avoid court but they would like to have the resolution passed in any case.

Olcott moved and Morrison seconded a motion to introduce and read Ordinance 81-22 by title only.

Clerk Connors read Ordinance 81-22 by title only.

ORDINANCE 81-22 To Amend BMC re: 30-Minute Parking Zones

Olcott moved and Morrison seconded a motion to adopt Ordinance 81-22.

Porter read the legislative synopsis and gave the committee report with a Do Pass recommendation of 7-2.

Service said she is still not sure that the Red Cross lot can't be used more, noting that the survey by the Traffic Commission shows that the lot has a lot of vacant spaces most of the day.

Olcott, sponsor of the ordinance, responded that the lot is quite difficult to get in and out of and these spaces would just be for pickups and deliveries, mainly for volunteers. He has checked the lot every day for the past week and it is highly utilized. He realizes that Red Cross personnel won't be the only ones using it, but it is clear that the Poplar's could also put the space to use.

Allison and Murphy agreed that it is desirable to have a couple spaces for temporary parking in this busy area.

Olcott said that it can be tried on a trial basis, and if it is abused or not used it can be changed again. He called it a partial solution to a congested area.

Towell said that it wouldn't be so congested if parking hadn't been taken off Seventh Street. Ideally, the Red Cross would not locate in such an area.

Morrison said the area has been congested since the 1950's.

Ordinance 81-22 was then adopted by a roll call vote of Ayes: 9, Nays: 0.

Olcott moved and Morrison seconded a motion to introduce and read Ordinance 81-14 by title only.

Clerk Connors read Ordinance 81-14 by title only.

Olcott moved and Morrison seconded a motion to adopt Ordinance 81-14.

Porter read the legislative synopsis and gave the committee report of no recommendation.

Planning Director Tim Mueller explained that the property is on the south side of Cottage Grove at the intersection of Indiana Avenue. The initial petition was to rezone the entire piece of property, but the Plan Commission adopted an amendment to rezone only the south 77 feet while leaving the house on the north edge in tact. The petitioner had no plans for the house and the Commission wanted to avoid further commercial expansion north on Indiana. The lot will be used for parking for the Tao Restaurant and bakery, but it will need setback variances since it will only be 50 feet by 77 feet.

Murphy said he lives a block from the property and he urged the Council to vote for the rezoning. The Tao has contributed a great deal to the area, particularly compared to what used to be on the site.

Service asked if the landscaping plan is adequate and Mueller replied that there will have to be site plan approval later, but their plans will have to be up to the new landscaping provisions.

Olcott said he used to live in the area and the Tao is the best thing that ever happened to that corner. They have done an excellent job with their developments.

Ordinance 81-14 was then adopted by a roll call vote of Ayes: 9, Nays: 0.
