In the Common Council Chambers of the Municipal Building held on May 6, 1981, with Councilpresident Towell presiding over a regular session of the Common Council.

Councilmembers present: Allison, Towell, Olcott, Morrison, Murphy, Porter, Hogan, Dilcher and Service.

Councilmembers absent: None

Towell read the agenda summation.

Service commended the Fire Department for the excellent way they handled the Towne Cinema fire. She said they prevented the fire from spreading to other businesses which could have been a major disaster. She said the Council should look at the fire codes to see if there are any steps that might be taken to prevent another fire in the future.

Olcott commended Dorothy Stancombe, Assistant Parks and Recreation Director, for her twenty-two years of service to the City. He is very sorry to see her leave, and he is proud to have had the chance to work with her.

Allison thanked the Human Resources Department for their efforts in promoting and arranging the Blooming Fair plant exchange last Saturday, noting that the program was a great success with over 200 people participating. She thanked Tom Dixon for his work for Operation City Beautiful in pursuing funds for the flowering tree project in Miller-Showers Park.

Towell read a letter he will send to Richard Burch, Building Inspector, upon his retirement in his eightieth year after fifteen years with the City.

There was no Message from the Mayor.

Towell announced appointments to several Boards and Commis-Pam Service will be appointed to the Title XX Advisory Board; Kathy Dilcher will be appointed to the Workable Programs Committee; and John Porter will be the Council's representative to the Utilities Citizens Advisory Committee.

There were no Petitions or Communications.

Fire Chief Larry Fleener said he was to give a report on the Towne Cinema fire but since lab tests have not been completed he will have to postpone the report.

Olcott moved and Morrison seconded a motion to introduce and read Ordinance 81-39 by title only.

Clerk Connors read Ordinance 81-39 by title only.

Olcott moved and Morrison seconded a motion to adopt Ordinance 81-39.

Murphy read the legislative synopsis and gave the committee report with a Do Pass recommendation of 8-0.

Allison asked if the access problems were resolved and Planning Director Tim Mueller replied that the petitioner had appealed to the Board of Zoning Appeals since the staff had recommended moving the access to the south to avoid problems with the intersection of Whitehall and Adams, but the BZA overruled the staff and said the drive could stay where it was because of low traffic volumes.

Morrison said he would recommend keeping the drive where it is.

Ordinance 81-39 was then adopted by a roll call vote of Ayes: 9, Nays: 0.

Olcott moved and Morrison seconded a motion to introduce and read Ordinance 81-41 by title only.

Clerk Connors read Ordinance 81-41 by title only.

Olcott moved and Morrison seconded a motion to adopt Ordinance 81-41.

Murphy read the legislative synopsis and gave the committee report with a Do Pass recommendation of 7-0-1.

Ordinance 81-41 was then adopted by a roll call vote of Ayes: 9, Nays: 0.

Olcott moved and Morrison seconded a motion to introduce and read Ordinance 81--48 by title only.

Clerk Connors read Ordinance 81-48 by title only.

Olcott moved and Morrison seconded a motion to adopt Ordinance 81-48.

Murphy read the legislative synopsis and gave the committee report with a Do Pass recommendation of 9-0.

Olcott said he hates to see Mr. Stewart, a neighbor adjacent to the retirement community, landlocked and added that he hopes the petitioners will work with him to come up with a solution. Mr. Stewart has very valuable land and it should have access to a City street.

Ordinance 81-48 was then adopted by a roll call vote of Ayes: 9, Nays: 0.

Frank Barnhart, attorney for the petitioner, said this is the last meeting they should have to come to, and he thanked the Council and the City for their cooperation.

Olcott moved and Morrison seconded a motion to introduce and read Ordinance 81-43 by title only.

Clerk Connors read Ordinance 81-43 by title only.

Olcott moved and Morrison seconded a motion to adopt Ordinance 81-43.

Murphy read the legislative synopsis and gave the committee report of no recommendation.

City Engineer Jeff Fanyo said the City had proposed to make Fair-view one-way south to eliminate traffic backup at First and Fair-view and First and Rogers. This amendment will allow easier egress/ingress for ambulances.

Towell questioned the location of the ambulance service, stating that they will exit onto a small street, and suggested that it would be better to have them exit onto Rogers. He concluded that this amendment may increase the time it takes for an ambulance to reach its destination.

Mark Fritz, Vice President of Bloomington Hospital, said that the ambulance service was placed where it was because there was no where else to put it. A renovated house is nearby to house the ambulance crews, and they had no such house on Rogers. With Fairview one-way north, there is one hour in the late afternoon when ambulances had difficulty from Fairview to Rogers. He noted that this will also facilitate traffic for the hospital's laundry and supply room on Morton with access to First Street.

Towell said the City is making a major investment in the underpass for the benefit of the hospital. He said just because a house is nearby is not justification for putting the ambulances in an inconvenient place. ORDINANCE 81-41 Amend Zoning re: 1412 W. 5th from RL to BA (Quality Htg. & Air Cond.)

Mr. Fritz replied that they are concerned about run times also, but considering they received 100 more calls in April of 1981 than in 1980, they are doing well with an average run time under six minutes.

Fire Chief Larry Fleener said the location does seem to be a little off the beaten track, but if it works well for the hospital then it's fine. He is concerned, however, about ambulances coming out on a blind alley. He concluded that Second and Rogers would be a better location, probably cutting 30 seconds off the run time since it would be on an arterial street.

Mr. Fritz reminded the Council that all runs do not originate from the hospital. Ambulances are also stationed at the E. Third Street station, at the Police Department, and at I.U.

Olcott said it seems that this amendment will aggravate traffic at First and Rogers. Now traffic can come up First, but this will force all the traffic to go west off Allen or onto Rogers.

Jeff Fanyo replied that the amendment will keep the traffic off residential streets. Traffic counts show 312 cars per hour at the intersection of First and Rogers and only 83 at First and Dodds, so this will help to move traffic further down First.

There was general discussion concerning traffic counts, traffic patterns, etc. with Morrison stating that traffic in the area is worse than ever, and this will force traffic onto S. Adams.

Murphy moved and Porter seconded a motion to divide the question. Motion carried by a roll call vote of Ayes: 7, Nays: 2 (Allison and Olcott).

Murphy moved and Porter seconded a motion to adopt Section II concerning No Parking on E. Atwater.

Olcott said cars are parked all along the south side of Atwater east of Mitchell, and sometimes they are parked right on the road, creating a dangerous situation.

Motion carried by a vote of Ayes: 9, Nays: 0.

Olcott moved and Allison seconded a motion to adopt Section I concerning Fairview one-way south. Olcott said he would like to know where all the ambulances are stationed since he thought they all originated out of the hospital.

Service asked if the Council denied the request if the hospital would move the ambulance site and Mr. Fritz replied that they don't have anyplace else to put it and the only thing that would happen is slow-down of traffic, including ambulances.

Murphy said he could not believe that there was not long-range planning to take care of this problem.

Allison said she is very grateful that the hospital took over the ambulance service at a time when they are also under budgetary restraints. Perhaps in the future the hospital will listen to the Council's suggestions with their continuing expansion plans.

Carl Chambers, Security Director for the hospital, said that the congestion in the could present a serious hazard between the times of 3:55 to 4:40 p.m. when the factories let out. He said the Council should not penalize the community by denying the amendment.
