In the Common Council Chambers of the Municipal Building held on July 25,1981, 8:00 p.m., with Councilpresident Towell presiding over a special session of the Common Council. An executive session re: personnel was held at 7:30p.m. prior to the special session.

COMMON COUNCIL SPECIAL SESSION SALARY ORDINANCES JULY 25, 1981

Councilmembers present: Morrison, Allison, Murphy, Porter, Towell, Olcott and Service.
Councilmembers absent: Dilcher and Hogan.

ROLL CALL

Councilpresident Towell read the agenda summation.

AGENDA SUMMATION

There were no messages from Councilmembers.

MESSAGES FROM COUNCILMEMBERS

Mayor McCloskey stated that he felt that the salary ordinance as originally submitted was reasonable, equitable and rational. He added that he understood opposition to 'merit factor' increases and felt the salary ordinance provided allocations of equity considering positions of differing amounts of responsibility. The Mayor said he had talked to Councilmembers both individually and as a group on a compromise package that he felt was satisfactory.

Olcott moved and Morrison seconded a motion to adopt Ordinance 81-75.

Towell read the legislative synopsis and reported that there was no committee report.

Olcott moved and Morrison seconded a motion to amend Ordinance 81-75 as follows:

Olcott moved and Morrison seconded a motion to adopt Ordinance 81-75 as amended.

Olcott moved and Morrison seconded a motion to read Ordinance 81-76 by title only.

Deputy Clerk Saperstein read Ordinance 81-76 by title only.

Olcott moved and Morrison seconded a motion to adopt Ordinance 81--76.

Motion carried by a roll call vote of Ayes: 7, Nays: 0.

Mayor McCloskey then stated that the fact that only one member of the City of Bloomington work force did not get at least a seven percent raise disturbed him.

Towell then said that the Council had had various demonstrations all week from the Administration about Ordinance 81-75. He added that relations between the Council and the Administration had deteriorated during the week. Long before any positions were taken by members of the Council, those demonstrations had already started. Towell ended his statement by saying that if there was any 'not taking of advice', he thought it was somewhat the doing of the Administration.

The meeting was then adjourned at 8:35 p.m.
