# PETITIONS AND COMMUNICATIONS

Tim Mueller, Director of the Planning Department, said he wanted to clarify a confusing article that appeared in the Herald-Telephone last week. He said the article was in reference to a rezoning at the N.E. corner of Moores Pike and College Mall Road for the Noble Roman Corporate Headquarters and an office park. Mueller said the implication in the article was that because of disagreements with the Planning staff the rezoning was denied and in a holding pattern. Mueller said there were very few rezonings that did not have disagreements but the rezoning was approved as a PCD. He added that any holding that was taking place was for their (Noble Romans') own private considerations.

Barry Wilson, Vice-President of Horizon Communications, spoke before the Council to explain the confusion over some of their marketing techniques for Cable T.V. Wilson explained that a new device is being put in for Cable T.V. viewers that allows all T.V. viewers the chance to view Cable T.V. for 2-3 days. He said they asked that those who did not want their service, to respond or else be billed. Wilson said because of the confusion this caused they would not use that type of marketing technique again.

Councilmember Kinzer, sponsor of the ordinance, explained that this ordinance updates the old one and makes the cab system more efficient.

Councilmember Richardson said this type of ordinance makes it difficult for the private sector to begin a cab company. He added that he did not think the city should legislate that cab companies must provide a 24 hour service.

Councilmember Young said the cab company provides a good service for the community but the new ordinance is not needed and was a waste of time.

Councilmember Morrison said the ordinance protects a local business to keep a large cab company from moving in and taking over at high volume times. He said he thinks it is a good ordinance.

Councilmember Richardson said that the cab business should compete like any other business in the community.

Councilmember Richardson moved and Councilmember Middleton seconded the motion to divide the question to separate the first two sentences of the ordinance to have it read 'Section I. Chapter 4.24 of the Bloomingto Municipal Code entitled "Taxicabs", shall be repealed'.
