In the Common Council Chambers of the Municipal Building held on July 15, 1976, with Councilpresident Blume presiding. The meeting began at 7:35 p.m.

Councilpresident Blume then gave the agenda summation Annual Report from the Sanitation and Engineering Departments. For second reading, Appropriation Ordinance 76-13, To Appropriate Funds from the Local Road and Street Fund to Fund #7. Under First Reading, Appropriation Ordinance 76-14, To Appropriate Funds from the Ceneral Fund to Department of Human Resources, from Federal Revenue Sharing to Controller's Office; and from Federal Revenue Sharing to Transit; Appropriation Ordinance 76-15, To Appropriate Funds from the General Fund to the Board of Public Works and from Federal Revenue Sharing to Parks and Recreation; Ordinance 76-46, To Amend Zoning Maps re: 901 W. First Street RS to SM; Ordinance 76-47, To Amend Zoning Maps re: SE corner of College Mall Road and Moore's Pike; Ordinance 76-48, To Repeal and Re-enact Chapter 18.04 of the Bloomington Municipal Code, entitled, "Fire Prevention Code"; and Ordinance 76-49, To Transfer the Balance of the Parking Meter Fund and of Parking Meter 'A' Sinking Fund to the General Fund.

Councilmember Olcott noted that Bloomington has a representative in the summer Olympics in Montreal with Jennifer Hooker in the women's swimming competition. He wished her good luck in the games.

Councilmember Richardson remarked that there will be a group of interested citizens making a trip to Marion, Indiana, to tour the juvenile center there. He reported on the progress being made to acquire a Temporary Shelter Care Facility in Monroe County, noting that someone has already donated land for the Facility. He invited interested persons to meet on Tuesday morning, July 20 to make the trip to Marion. He also congratulated Jennifer Hooker on qualifying for the Olympics in Montreal.

Noble Baugh then gave the annual report for the Sanitation Department. He asked for questions from Councilmembers. He said the Sanitation Department collects from twenty-five to thirty tons of garbage per month. In answer to a question from Councilmember Olcott regarding the feasibility of the city contracting with a private company for garbage pick-up, he replied that he felt it was better for the City to do it, since Sanitation also collects large items such as refridgerators, furniture, etc, which private contractors do not. He said the City is saving \$40,000 by working through the Street Department.

Councilmember De St. Croix commented that the number of complaints regarding garbage pickup has decreased since the City took over the service. He then moved that the Sanitation Department's annual report be accepted as submitted. Councilmember Middleton seconded the motion. Unanimous consent of Council. REGULAR SESSION

Councilmember Richardson asked how the I.U. off campus rental inspections are progressing.

Norman Perry answered that the system seems to be working well. He added that Thursday is the day when I.U. off campus unit inspections are done.

Councilmember Olcott asked what is being done about the surface water runoff in different areas of town.

Norman Perry replied that a consultant has been hired, and began work on the problem last week. He said he met with Redevelopment to work out an approach on the inventory and storm sewers, with most of the program being handled in the Engineering Department. He continued that an assistant city engineer will be hired next year when Marvard Clark retires. He also added that there will be funds to hire four temporary employees to locate all of the existing storm sewers, and to determine their condition. He said many culverts are silted completely full.

Councilmember Towell remarked that he is glad to see that Engineering is finally doing something about these problems, which have been talked about for years.

Councilmember De St. Croix moved and Councilmember Morrison seconded a motion to accept the Engineering Department's annual report as submitted. Unanimous consent of the Council.
