CITY OFFICIALS PRESENT

Councilpresident De St. Croix began the meeting with a summation of the agenda, to consider Salary Ordinance 75-46. He called for messages from the Council members, then the Mayor, and being none moved onto the business of Ordinance 75-46.

MESSAGE FROM THE MAYOR

Councilman Morrison moved that Ordinance 75-46 be introduced and read by the Clerk by title only. Seconded by Councilman Mizell.

ITEMS FOR DISCUSSION/VOTE

Councilpresident De St. Croix: It has been moved and seconded that Ordinance 75-46 be introduced and read by the Clerk by title only.

Ordinance 75-46 Salary

The motion passed by a unanimous voice vote of the Council.

Karel Dolnick, City Clerk, read Ordinance 75-46 by title only.

Councilman Morrison moved that Ordinance 75-46 be adopted. Seconded by Councilwoman Davis.

Councilpresident De St. Croix: It has been moved and seconded that Ordinance 75-46 be adopted. Now we will open it for discussion.

Mayor McCloskey: I will be very brief.

I would just like to say that the revised Ordinance that you have before you reflects various concerns of the Council and the Mayor, primarily coming from one work session. It is not perfect, but I endorse it, and urge its passage. Thank you.

Councilpresident De St. Croix: Thank you, Mayor McCloskey. You have before you, revised Ordinance 75-46. We will need a motion to amend 75-46, to reflect these changes.

Councilwoman Davis: I move that we amend Ordinance 75-46 to delete the Police and Fire and Utility Budget, salary ordinance part, and for the revised or amended budget to be read in its entirety by the Clerk. Seconded by Councilman Morrison.

Karel Dolnick, City Clerk, read the Ordinance 75-46 amended version in its entirety.

This is the Salary Ordinance as revised 75-46, as moved and seconded by the Council, and to delete the section for Police and Fire and Utilities. Do we have discussion from the Council? Discussion from the floor? The motion is on the amendment of 75-46 to delete Fire & Police Salaries, to delete Utilities, and insert the salaries as read. Clerk Dolnick, please call the roll.

The motion was passed to amend Ordinance 75-46 by a ROLL CALL VOTE of AYES: 8, NAYS: 0.

Comments made during the vote by Councilpresident De St. Croix: Before I vote, Councilman Towell, if you choose to have a recorded vote on the amendment, which is the revised Ordinance 75-46? This Ordinance 75-46 is the result of the Committee reports accepted by the Mayor and the Council recommendations for the salaries, or would you care not to vote?

Councilman Towell: Well, this would just put it in to be further discussed?

Councilpresident De St. Croix: Yes, that is correct sir.

Councilman Towell: I'll vote yes.

Councilpresident De St. Croix: I'll vote aye too. Ordinance 75-46 is amended by a unanimous vote of the Council, 8 to nothing. Do we have a motion for adoption as amended?

Councilman Morrison: I move that Ordinance 75-46 be adopted as amended. Seconded by Councilwoman Davis.

Councilpresident De St. Croix: It has

been moved and seconded that we adopt Ordinance 75-46 as amended. Is there any discussion?

Councilman Towell: Can I have about three or four minutes to browse?

Councilpresident De St. Croix: Mayor McCloskey, do you have any remarks?

Mayor McCloskey: I think I have said all I want to say.

Councilpresident De St. Croix: Thank you. Councilmembers? Do you have anything to say? I would like to point out that the Council Committees have worked well and long and hard on the City Budget, trying to work with the Mayor's Office, and the Mayor's Office has cooperated fantastically on this effort. I think we have come up with a joint proposal here that accomodates the interests of everybody involved and I would just like to say thank you to the Mayor and the Mayor's staff, to Council staff and the other members of the Council who all worked pretty long and hard on this. O.K., the motion is for the adoption of Ordiance 75-46 as amended. Are we prepared now? Clerk Dolnick, please call the roll.

Ordinance 75-46 is passed as amended by a ROLL CALL VOTE of AYES: 8, NAYS: 0.

Councilpresident De St. Croix: Ordinance 75-46 is adopted unanimously by a roll call vote of 8 to nothing. Last item on the agenda of the Council meeting, being finished, dismissed.

There being no further business, the Council adjourned at 7:43 p.m.
