Councilman De St. Croix moved that Resolution No. 73-11 be adopted. Councilman Towell seconded the motion.

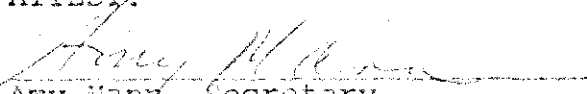
RESOLUTION No. 73-11 WAS ADOPTED BY A ROLL CALL VOTE OF AYES 5, Nays 0.

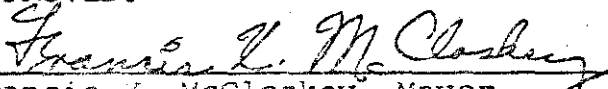
