

In the Council Chamber of the Municipal Building, on Monday, July 31, 1972, at 7:45 p.m., E.S.T., with Council President pro tem Brian De St. Croix presiding

Members Present: James Ackerman, Richard Behen, Hubert Davis, Brian De St. Croix, Wayne Fix, Sherwin Mizell, Jack Morrison, Alfred Towell.

ROLL CALL

Members Absent: Charlotte T. Zietlow was out of town.

Councilman Towell moved that Ordinance No. 72-57 be introduced and read by the Clerk by title only. Councilman Morrison seconded the motion.

Ordinance No. 72-57
Salary Ordinance

Councilman Towell said that he felt reading by title only was sufficient due to the publicity the ordinance had received in the local media.

The motion was carried by a unanimous voice vote.

Councilman Towell moved that Ordinance No. 72-57 be approved. Councilman Morrison seconded the motion.

Councilman Davis moved to divide the question and consider Ordinance no. 72-57 department by department. Councilman Towell seconded the motion. The motion was carried by a unanimous voice vote.

Councilman Ackerman moved to further divide the question so that Ordinance no. 72-57 could be considered line by line. The motion was defeated by a roll call vote of Ayes 2, Nays 6. (Ayes: Ackerman, Fix).

Councilman Towell moved to lower the salary of the Administrative Aide in the Mayor's office to \$13,000.00 and to approve the salary at that level. Councilman Behen seconded the motion.

Councilman Ackerman moved to amend the motion and to lower the salary of the Administrative Aide to \$12,000.00. Councilman Fix seconded the motion. The amendment to the amended motion was carried by a Roll Call Vote of Ayes 5, Nays 3 (Nays: Towell, Mizell, Davis).

The question was called. The Salary for the Administrative Aide in the Mayor's Office was approved at \$12,000.00 by a Roll Call Vote of Ayes 6, Nays 2 (Nays: Towell, Mizell)

Councilman Towell moved to approve the salary of the Executive Secretary for the Mayor's Office at \$9,500.00. Councilman Davis seconded the motion. The motion was carried by a Roll Call Vote of Ayes 5, Nays 3 (Nays: Morrison, Ackerman, Behen)

Councilman Ackerman moved to approve the Secretary position in the Mayor's Office at \$2.75 @ hour. Councilman Towell seconded the motion. The motion was approved by a Roll Call vote of Ayes 8, Nays 0.

Since the salaries of the members of the Common Council are set by ordinance, no action was required on that item.

Councilman Ackerman moved that the salary for the Secretary/Aide to the Common Council be reduced to \$6,500.00 and approved at that level. Councilman Davis seconded the motion. The motion was approved by a Roll Call Vote of Ayes 5, Nays 2, 1 Abstention. (Nays: Towell, Mizell; Abstention: Behen)

Councilman Behen moved that the salaries for the Controller's Office be approved as listed. Councilman Davis seconded the motion. The motion was carried by a Roll Call vote of Ayes 8, Nays 0.

Councilman Towell moved that the salaries for the City Clerk's Office be approved as listed. Councilman Morrison seconded the motion. The motion was carried by a Roll Call vote of Ayes 8, Nays 0.

Councilman Towell moved that the salaries listed for the City Judge's Office be approved as listed. Councilman Mizell seconded the motion.

Councilman Morrison moved that the motion be amended by lowering the City Court Bailiff's pay to that of a Sergeant, \$10,290. Councilman Ackerman seconded the motion. The motion was carried by a voice vote of Ayes 5, Nays 3 (Nays: Towell, Davis, Fix)

Councilman Towell moved that the salaries, as amended, for the City Judge's office be approved. Councilman Behen seconded the motion. The motion was carried by a Roll Call Vote of Ayes 8, Nays 0.

Councilman Behen moved that the Salary for the Deputy City Treasurer be approved as listed. Councilman Mizell seconded the motion. The motion was carried by a Roll Call vote of Ayes 8, Nays 0.

Councilman Towell moved that the salaries for the City Attorney-Legal Department Office be approved as listed. Councilman Davis seconded the motion. The motion was carried by a Roll Call Vote of Ayes 6, Nays 2 (Nays: Mizell, Behen)

Councilman Towell moved that the Board of Public Works salaries be approved as listed. Councilman Mizell seconded the motion.

Mayor McCloskey recommended that the Salary for the Board of Works-Utilities Assistant be set at a maximum of \$10,000.00 and that it be put entirely under the Utilities Section of the Salary ordinance, with the understanding that the time and salary should be split 70% utilities and 30% board of works. Councilmen Towell and Mizell accepted the Mayor's recommendation and it was incorporated into their motion.

The motion was approved by a Roll Call vote of Ayes 6, Nays 2 (Nays: Morrison, Behen)

Councilman Ackerman moved that the Salary for the Clerk-Secretary for the Board of Public Safety be approved as listed. Councilman Towell seconded the motion. The motion was carried by a Roll Call Vote of Ayes 8, Nays 0.

Councilman Morrison moved that the salaries listed for the Planning Department be approved as listed. Councilman Mizell seconded the motion. The motion was carried by a Roll Call vote of Ayes 8, Nays 0.

Councilman Towell moved that the salaries for the Engineering Department be approved as listed. Councilman Mizell seconded the motion.

Councilman Morrison moved to amend the motion by deleting the position of Street Inspector, or reducing the salary for that position to zero. Councilman Behen seconded the motion. The motion was defeated by a Roll Call vote of Ayes 2, Nays 6 (Ayes: Morrison, Behen).

The question was called on the motion to approve the salaries as listed. The motion was carried by a Roll Call Vote of Ayes 6, Nays 2 (Nays: Morrison, Behen)

The Mayor recommended to the Council that the salary for the Administrator of Transportation and Fleet Maintenance be reduced to \$15,000.00 Councilman Towell moved that the salaries

for the Transportation and Motor Vehicle Highway Department be approved as listed, with the modification recommended by the Mayor. Councilman Mizell seconded the motion. The motion was carried by a Roll Call Vote of Ayes 8, Nays 0.

Councilman Towell moved that the salaries for the Redevelopment Department be approved as listed. Councilman Mizell seconded the motion. The motion was carried by a Roll Call vote of Ayes 8, Nays 0.

Councilman Towell moved that the salaries for the Fleet Maintenance Department be approved as listed. Councilman Morrison seconded the motion. The motion was approved by a Roll Call Vote of Ayes 8, Nays 0.

Councilman Towell moved that the salaries for the parks and recreation department be approved as listed. Councilman Morrison seconded the motion. Mayor McCloskey recommended that the Director of the Older Americans Center position be added to the ordinance at a maximum salary of \$9,800.00. Councilmen Towell and Morrison accepted the Mayor's recommendation and it was incorporated into their motion. The motion was carried by a Roll Call Vote of Ayes 8, Nays 0.

Councilman Towell moved that the salaries listed under the Humane Association be approved as listed. Councilman Ackerman seconded the motion. The Mayor recommended that the words "Humane Association" be stricken and the words "Animal Control Commission" be put in their place. The recommendation was accepted and made a part of the motion. The motion was carried by a Roll Call Vote of Ayes 6, Nays 2 (Nays: Morrison, Behen)

Councilman Towell moved that the salaries for Rosehill Cemetery be approved as listed. Councilman Morrison seconded the motion. The Mayor recommended that the position of Bookkeeper be added with a maximum salary of \$722.24. The Mayor's recommendation was accepted and incorporated into the motion. The motion was carried by a Roll Call Vote of Ayes 8, Nays 0.

Councilman Towell moved that the salaries listed for the Human Rights Commission be approved as listed. Councilman Morrison seconded the motion. The motion was carried by a roll call vote of Ayes 6, Nays 1, 1 Abstention (Nay: Behen; Abstention: Morrison)


Councilman Towell moved that the salaries listed for the redevelopment department be approved as listed. Councilman Mizell seconded the motion. The motion was carried by a roll call vote of Ayes 8, Nays 0.

Councilman Towell moved that the salaries listed for the utilities department be approved as listed. Councilman Morrison seconded the motion. Councilman De St. Croix moved to amend the motion by reducing the salary listed for the Administrative Assistant in Utilities to \$12,000.00. Councilman Morrison seconded the motion to amend; the motion was carried by a Roll Call vote of Ayes 6, Nays 2 (Nays: Towell, Fix)

The question was called on the amended listing of salaries for the utilities department. The motion was carried by a roll call vote of Ayes 8, Nays 0.

Councilman Towell moved that Ordinance No. 72-57 be approved as amended. Councilman Ackerman seconded the motion. The motion was carried by a roll call vote of Ayes 6, Nays 2 (Nays: Morrison, Behen)

The special session of the Common Council was adjourned at 11:10 p.m., E.S.T.
