Councilman Harry Day stated he had a note from the Mayor to present his recommendation to the Council the appointment to the Human Rights Commission of the following five people whose term will expire first of March: Father Robert Borchertmeyer, Betty Rowen, Dr. Jerry Ruff, Mark L. Schenk and Professor Hillard Trubitt.

Councilman Harry Day moved that the five above named people be reappointed for a three year term as of the first of March. Councilman Faris seconded the motion, and it carried.

Councilman Fee moved that applications for taxi cab licenses to Yellow Cab and Campus Cab be approved for year 1971. Councilman Clegg seconded the motion, and it carried.

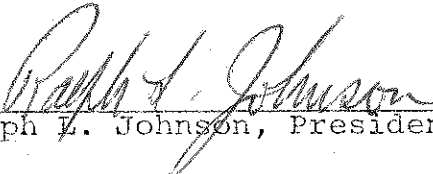
MESSAGE FROM MAYOR
