Councilmanic Districts

The Clerk read proposed Ordinance No. 71-11 by title only.

Mr. James Cotner, City Attorney stated that the City was faced with the problem of complying with two separate laws, one, the Federal Law which asks that districts be set up only as one man, one vote concept, but the 1970 census figures were not received by the Clerk until a few days ago and have not been certified. The State law provides that no ward may be changed after January 1 of any City Election year. He stated some districts have been changed by the County since the 1967 redistricting and there were cases where precincts cross district lines. State law prohibits precincts from cutting district lines. He said the County's action of establishing precincts which cross city district lines could probably be over-turned by the Court, which would re-establish the 1967 districts.

Mrs. Jamie Murphy, County Clerk said the Commissioners have until March 10, 1971, to change precincts back within the old districts, and if they do not change them, then the Court will be asked to change them.

Councilman Fee moved that proposed Ordinance No. 71-11 be adopted. Councilman Clendening seconded the motion.


Councilman Clyde Day moved that Claims and Payrolls presented for payment March 5, 1971, be allowed and approved. Councilman Morrison seconded the motion.
