J. W. Riggenberg noted that there might be an active movement afoot to reimburse the shopper for his parking expense through the individual merchant.

A member of the audience objected to the placement of meters in front of private residences.

Grace Martin questioned whether the tax rate would be changed and the Council responded that it would not be.
