Councilman Fee asked that the Audience stand in a moment of silence in honor of the late Mike Rabold.

Councilman Faris moved that the Minutes of October 1, 1970, meeting be approved at the first meeting of Council in November. Councilman Clegg seconded the motion. Motion carried.

REMONSTRANCES AND
OBJECTIONS

Councilman Faris moved that proposed Ordinance No. 70-45 be advanced to second reading and that it be read by title only. Councilman Clyde Day seconded the motion.

ORDINANCES - SECOND
READING

The Clerk read proposed Ordinance No. 70-45 by title only.

Proposed Ordinance No. 70-45, An Ordinance to Amend Municipal Code of City Bloomington, by amending Chapter 17, entitled, "Motor Vehicles and Traffic" by amending Chapter 195 entitled, "No Parking Zones, Section 206 entitled, "Stop Intersections"

Councilman Clendening moved that proposed Ordinance No. 70-45 be amended by deleting the following:

"Both sides of East 2nd Street shall be deemed "No Parking" from South High Street to South College Mall Road."

Councilman Morrison seconded the motion.

Roll call vote: Ayes 4, Nays 5
(Gray, Johnson, Harry Day, Faris, Clegg)

Chief East stated any parking would hamper traffic and create traffic hazards.

Colonel Inman stated a recommendation was made by Traffic Commission and passed unanimously.

Councilman Johnson stated that the biggest complaint was people parking on both sides of street to attend Little League Ball Games at schools located in vicinity. He also stated there was adequate off-street parking

except during various ball game seasons.

Mr. Irvin Rumble spoke with reference to apartment complex, stating the tenants had ample parking, but if guests come to visit they have no place to park except on the street, and that he saw no traffic hazard from parking in area.

Attorney Barnhart suggested the parking ban along that particular area be from 7:00 A.M. to 7:00 P.M., but Chief East did not think this would solve the problem.

Councilman Faris stated in view of the fact there are three schools in area, children involved in going to and from school and the moving of traffic, he asked that the amendment be defeated, and that the proposed ordinance be passed.

Roll call vote: Ayes 5, nays 4.

Councilman Harry Day moved that nominations be approved by the Council. Councilman Faris seconded the motion, and it carried unanimously by voice vote.

Councilman Harry Day commented that the Council had under consideration a Mass Transportation Ordinance and that final copies of the proposed ordinance will be available within the next two weeks, probably not until the Council's November 5, meeting.

Councilman Harry Day also announced that at long last, all the bugs are out of flouridation program and scheduled to start the following Thursday. The City is to put one-half per million of the necessary chemical into the city water system, and this will be increased to the one part per million level required to help prevent tooth decay within two days after that.
