Councilman Madden said he would like to see all rezoning stopped until a City Planner is hired. He suggested that a resolution be prepared to request that Mayor Hooker and the Plan Commission freeze all rezoning activities until such time as a city planner is appointed and instructed to proceed with the creation of a master plan. He asked also that Mayor Hooker report publicly the progress being made in attracting a competent planner to Bloomington.

Councilman Clegg said this is the first council in the history of the City of Bloomington that has done anything about planning. He said he has faith in his colleagues and knows they will continue to follow the principles of good planning either under or without pressure. Since Council will still have to make the final decision in rezoning, Mr. Clegg said he, as an individual, would hate to see rezoning or anything requiring Council action stopped completely for an undetermined period of time.

Councilman Day said he was glad Councilman Madden had expressed his feelings but he could not accept Mr. Madden's remedy. Dr. Day said he felt the Administration should be given ample time to make a good choice for the position of City Planner.

Council President Faris said the Council had put forth much time and effort in the two-mile fringe area and he felt good planning had been done even without a city planner. Councilman Johnson concurred.

Councilman Day announced that the Reverend James L. Ray had been appointed as the sixth member of the Bloomington Fair Housing Commission. Reverend Ray is the minister at St. Marks Methodist Church.

Councilman Day said he felt more City department heads should attend more of the Council meetings. He suggested that reports be given occasionally by the department heads. Councilman Madden supported Dr. Day's opinion.

Council President Faris pointed out that there had been ten department heads present at the last Council meeting.

Mayor Hooker asked the Council to go on record as being in favor of school reorganization for the Greater Bloomington and Monroe County area and for the four-laning of Highway 37 from Bloomington to Indianapolis. He suggested they pass resolutions during the month of April if possible.

Councilman Day said nothing had been as ridiculous as the time situation and asked what was going to be done about it. He said it was possible that the government would change its position on the subject.

Mayor Hooker said he believed Bloomington would respond by keeping in step with Indianapolis.
