Councilman Fee moved that the minutes of the regular meetings of November 7 and November 21, 1968 meetings be approved as xeroxed and distributed. Councilman Johnson seconded the motion and it carried.

Ordinance No. 68-71-Zoning Ordinance-Lots 4,5 & 6 in Cottage Grove Addition, from R-3 to B-1

The Clerk read proposed Ordinance No. 68-71 by title only.

Councilman Fee moved that proposed Ordinance No. 68-71 be adopted. Councilman Clendening seconded the motion. Roll call vote: ayes 7, nays 0.

Councilman Johnson moved that proposed Ordinance No. 68-72 be advanced to second reading and be read by the Clerk by title only. Councilman Gray seconded the motion and it carried.

Ordinance No. 68-72-Zoning Ordinance-7.2 acres on State Road 37, South of Thompson Dairy Co. and 594 feet North of Rhorer Road, from B-1 to B-3

Councilman Johnson asked whether there had been any opposition to this proposed ordinance at the Plan Commission meeting. Councilman Clegg said there was some controversy over interference with the natural water course but when this problem was worked out, there was no further discussion and there had been no reference to opposition to the rezoning request. Councilman Clegg further stated there had been no opposition to any of the proposed resonings before the Council tonight.

Councilman Johnson moved that proposed Ordinance No. 68-73 be adopted. Councilman Clendening seconded the motion. Roll call vote: ayes 8, nays 0.

Councilman Johnson moved that proposed Ordinance No. 68-74 be advanced to second reading and be read by the Clerk by title only. Councilman Clegg seconded the motion and it carried.

Ordinance No. 68-74-Zoning Ordinance-1.35 acres West of State Road 37, North of City Limits, North of Marathon Service Station, from B-1 to B-3

Councilman Johnson moved that proposed Ordinance No. 68-74 be adopted. Councilman Clendening seconded the motion. Roll call vote: ayes 8, nays 0.

Voorhies, Associate Dean of Regional Campuses, School of Education, Indiana University, be appointed to the above post to serve for a period of four years, beginning January 1, 1969 and ending January 1, 1973. Councilman Clegg seconded the motion and it carried.


MESSAGES FROM MAYOR
