

REGULAR MEETING

THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, met in the Council Chambers in the Municipal Building on Thursday, April 21, 1966, at the hour of seven thirty o'clock (7:30 P.M.) E.S.T. in regular session with Mayor John H. Hooker, Jr. presiding.

Meeting called to order by Mayor Hooker.

A roll call of the Councilmen was taken by the Clerk-Treasurer.

Mayor Hooker explained the absence of Councilmen Derge and Fee. Councilman Derge is on a study assignment and Councilman Fee could not be with us due to illness in his family.

Meeting opened with invocation by Councilman Johnson.

Councilman Faris moved, seconded by Councilman Johnson, the minutes of the April 7, 1966 meeting of the Council be approved as published and distributed. Motion carried unanimously.

Councilman Moulden moved, seconded by Councilman Faris, proposed Ordinance 66-11 be advanced to second reading and read by title only. Motion carried unanimously.

The Clerk-Treasurer read proposed Ordinance 66-11 by title only.

Councilman Moulden moved, seconded by Councilman Faris, proposed Ordinance 66-11 be adopted. Upon a roll call vote the motion was carried unanimously.

Councilman Faris moved, seconded by Councilman C. Day, proposed Ordinance 66-12 be advanced to second reading and read by title only. Motion carried unanimously.

The Clerk-Treasurer read proposed Ordinance 66-12 by title only.

Councilman Faris moved, seconded by Councilman H. Day, proposed Ordinance 66-12 be adopted. Upon a roll call vote the motion was carried unanimously.

Councilman Moulden moved, seconded by Councilman C. Day, proposed Ordinance 66-13 be presented for first reading and read by the Clerk-Treasurer. Motion carried unanimously.

The Clerk-Treasurer read proposed Ordinance 66-13.

Councilman Moulden moved, seconded by Councilman C. Day, proposed Ordinance 66-14 be presented for first reading and read by the Clerk-Treasurer. Motion carried unanimously.

The Clerk-Treasurer read proposed Ordinance 66-14.

Councilman Moulden moved, seconded by Councilman Faris, proposed Ordinance 66-15 be presented for first reading and read by the Clerk-Treasurer. Motion carried unanimously.

The Clerk-Treasurer read proposed Ordinance 66-15.

Councilman Moulden moved, seconded by Councilman Johnson, proposed Ordinance 66-16 be presented for first reading and read by the Clerk-Treasurer. Motion carried unanimously.

The Clerk-Treasurer read proposed Ordinance 66-16.

Councilman Moulden moved, seconded by Councilman C. Day, proposed Ordinance 66-17 be presented for first reading and read by the Clerk-Treasurer. Motion carried unanimously.

The Clerk-Treasurer read proposed Ordinance 66-17.

Councilman Faris moved, seconded by Councilman C. Day, the City Attorney be instructed not to oppose the proposed petition to be filed in the Monroe Circuit Court by Wegmiller-Bender Lumber Company, Inc. to vacate Jackson Street from its intersection with 11th Street South for a distance of Two Hundred Six (206) feet, more or less, to a point where the end of Jackson Street abuts petitioners property. Subject to utility rights. Motion carried unanimously.

Gentlemen:

I.B.E.W. Local 1424 requests that the City Attorney be instructed not to oppose their petition to vacate that part of Davis Street east from its intersection with Fairview Street for a distance of 144' east.

In support of its request Petitioner would show that it is the owner of Lots Numbered 8, 9, 10, 11, 12, 13, 14, 15 and 16 of Duncans Addition (plat attached). That said street has never been used as a public roadway. That said street could not be opened without great expense and would not be valuable as a public street. Petitioner proposes to improve its facilities, which improvements would require the use of said street.

Councilman Faris moved, seconded by Councilman H. Day, this request be turned over to committee for investigation. Motion carried unanimously.

Mayor Hooker recognized the following citizens in attendance this evening:  
A group of students from the Fine Arts Department at Indiana University,  
Mrs. Clyde Day, wife of Councilman C. Day,  
Maude Bryan, senior citizen,  
Noble Baugh a representative of B & S Disposal.

Mayor Hooker stated an agreement was made between the City of Bloomington and the Monroe County Board of Commissioners, that all residents living in Monroe County who are occupying a household will be allowed to haul their trash to the city incinerator, and in turn the County will allow citizens of the City of Bloomington to use the County Dump on the West end of Road 48.

Councilman Faris moved, seconded by Councilman H. Day, proposed Ordinance 66-18 be presented for first reading and read by the Clerk-Treasurer. Motion carried unanimously.

The Clerk-Treasurer read proposed Ordinance 66-18.

Mayor Hooker suggested the Council might wish to have a discussion on proposed Ordinance 66-18 at this time as the members of the Humane Society were in attendance this evening.

Mr. Ronald Tackitt, President of the Humane Society said this ordinance

was satisfactory with the Society, and he thanked the Council for their help in this matter.

Councilman Faris moved, seconded by Councilman H. Day, the City enter into a lease agreement with the Monroe County Humane Society for the leasing of City owned property located on Highway #37 South, South of the National Guard Armory at site of the Bloomington Treatment Plant for the purpose of construction of an animal shelter, and the City Attorney be instructed to prepare the necessary legal documents. Motion carried unanimously.

Mayor Hooker stated there would be a SPECIAL MEETING of the Common Council on THURSDAY, APRIL 28, 1966 at seven thirty o'clock (7:30 P.M.) E.S.T. in the Council Room.

Councilman Faris stated the Council committee has met in regard to selection of two Councilmen and a City Clerk to fill the vacancies created by the City becoming a 2nd Class City.

Councilman Faris moved, seconded by Councilman Moulden, that Ermal Byers, 410 West Dodds be appointed to fill the vacancy on the Council for District # 4 effective May 1, 1966. Upon a roll call vote the motion was carried unanimously.

Councilman Faris moved, seconded by Councilman H. Day, that Robert L. Clegg, Jr., be appointed to fill the vacancy of Councilman-at-Large, effective May 1, 1966. Upon a roll call vote the motion was carried unanimously.

Councilman Faris moved, seconded by Councilman C. Day, that Mrs. Med (Marian) Tardy be appointed to the position of City Clerk, effective June 1, 1966, at the salary of \$5,500.00 per year. Upon a roll call vote the motion was carried unanimously.

Mayor Hooker announced the appointment of City Controller. The City Controller will be Howard A. Young, with the appointment effective June 1, 1966.

Mayor Hooker stated the Park and Recreation Department will advertise for bids on April 28th and May 5th for the construction of a new swimming pool, a new ice rink and the enclosure of Bryan Pool, with bids to be opened and read aloud by the Board of Public Work and Safety at four o'clock (4:00 P.M.) E.S.T. on Thursday, May 19, 1966.

Mayor Hooker stated we are waiting on action of the Indiana Public Service Commission to begin our work on the water expansion program. He further stated the Board of Public Works and Safety signed a contract with the Southern Monroe Water Corporation for the purchase of water from the City of Bloomington.

Councilman C. Day moved, seconded by Councilman Moulden, claims presented for payment on April 20, and April 22, 1966 be allowed. Motion carried unanimously.

No further business to come before the Common Council, Councilman Johnson moved meeting be adjourned.

Meeting adjourned at the hour of eight fifty-five o'clock (8:55 P.M.) E.S.T.
