

STATUTORY MEETING

THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, met in the Council Chambers in the Municipal Building, on Monday, August 30, 1965, at the hour of seven thirty o'clock (7:30 P.M.) E.S.T. in Statutory session for the purpose of adopting the Budget for 1966.

Meeting called to order by Mayor Hooker.

A roll call of the Councilmen was taken by the Clerk-Treasurer.

Mayor Hooker stated Councilman Derge was out of town on business and City Engineer Long is attending the American Public Works Association Convention in Los Angeles, California.

Councilman Fee moved, seconded by Councilman Faris, that the budgets for the calendar year 1966 for the General Fund be as follows:

TOTAL GENERAL FUND BUDGET \$1,105,151.00

Councilman Fee moved, seconded by Councilman Faris, that the General Fund budget be approved as stated. Upon a roll call vote, the motion was carried unanimously.

Councilman Fee moved, seconded by Councilman Faris, that the MVH/ Street Department budget for the calendar year 1966 be in the amount of \$235,550.00. Upon a roll call vote, the motion was carried unanimously.

Mayor Hooker stated that this amount is Bloomington's share of Motor Vehicle Highway Funds from the State. This is not a levy on local taxes.

Councilman Fee moved, seconded by Councilman Faris, that the Corporate Bond budget for the calendar year 1966 be in the amount of \$45,841.00. Upon a roll call vote, the motion was carried unanimously.

Mayor Hooker stated this is a legal obligation on the City's bonds and coupons which must be paid.

Councilman Fee moved, seconded by Councilman Faris, that the Rosehill Cemetery budget for the calendar year 1966 be in the amount of \$32,248.00. Upon a roll call vote, the motion was carried unanimously.

Councilman Fee moved, seconded by Councilman Faris, that the Police Pension budget for the calendar year 1966 be in the amount of \$53,857.00. Upon a roll call vote, the motion was carried unanimously.

Councilman Fee moved, seconded by Councilman Johnson, that the Fire Pension budget for the calendar year 1966 be in the amount of \$54,334.00. Upon a roll call vote, the motion was carried unanimously.

Councilman Fee moved, seconded by Councilman Moulden, that the Parking Meter budgets for the calendar year 1966 be as follows ----

Police	\$32,154.00
Street	\$11,404.00

Upon a roll call vote, the motion was carried unanimously.

Councilman Fee moved, seconded by Councilman Johnson, that the Parking Meter Facility budget for the calendar year 1966 be in the amount of \$32,680.00. Upon a roll call vote, the motion was carried unanimously.

Councilman Fee moved, seconded by Councilman Moulden, that the Parks and Recreation budget for the calendar year 1966 be in the amount of \$188,068.00. Upon a roll call vote, the motion was carried unanimously.

Councilman Fee moved, seconded by Councilman Johnson, that rules be suspended and Appropriation Ordinance 65-2 be advanced to second reading. Upon a roll call vote, the motion was carried unanimously.

Councilman Faris moved, seconded by Councilman Fee, that Appropriation Ordinance 65-2 be advanced to second reading and read by title only. Motion carried unanimously.


The Clerk-Treasurer read Appropriation Ordinance 65-2 by title only.

Councilman Fee moved, seconded by Councilman Moulden, that Appropriation Ordinance 65-2 be duly adopted. Upon a roll call vote, the motion was carried unanimously.

Mayor Hooker stated that we did not have more than eleven taxpayers represented this evening for the special meeting of the Common Council for the purpose of adopting Budgets for the operation of the City of Bloomington, for the calendar year 1966.


Councilman Fee moved, seconded by Councilman Johnson, that the meeting be adjourned. Motion carried unanimously.
