The meeting was opened with a moment of silent prayer by the Mayor.

Councilman Peace moved, seconded by Councilman Hickman, that the minutes of the last regular meeting of February 5, 1963, be approved; motion unanimously carried.

Councilman Peace presented Ordinance Number 3, 1963 for first reading by the Clerk-Treasurer.

The Clerk-Treasurer read Ordinance Number 3, 1963, which pertained to amending the 1962 Salary Ordinance.

Councilman Peace moved, seconded by Councilman Hickman, that Ordinance Number 3, 1963 be advanced to second reading and read by title only. Upon a roll call vote; motion unanimously carried.

The Clerk-Treasurer read, by title only, Ordinance Number 3, 1963.

Councilman Hickman moved, seconded by Councilman Faucett, that Ordinance Number 3, 1963 be duly adopted. Upon a roll call vote; motion unanimously carried.

Councilman Peace presented Ordinances Number 4,5,6,7,8,9, and 10 for first reading by the Clerk-Treasurer.

The Clerk-Treasurer read Ordinances Number 4,5,6,7,8,9, and 10.

Mr. James Kent, Attorney for Mr. and Mrs. Jack Sader, spoke to the Council regarding the re-zoning ordinance which had jsut be given first reading (#8).

Councilman Peace presented the following report from the Public Safety Committee.

Report to Council, From the Public Safety Committee.

Feb. 19, 1963.

At the Feb. 12, 1963 meeting of the Bloomington Traffic Commission the following recommendations were adopted and submitted to the Council for consideration and action.

- 1. Recommends that Yeild signs be installed in Fritz Terrace at the follwing intersections;
 - a. Cul-de-sac at the south and of Stoney Crest, YIELD to Meadow Lane.
 - b. Kingsley YIELD to Briarcliffe.
 - C. Meadow Lane YIELD to Kingsley.
 - d. Stoneycrest YIELD to Meadow Lane.
 - e. O'Briend Place YIELD to Stoneycrest.
 - f. Winding Way YIELD to Stoneycrest, north and south.
 - g. Stoneycrest YIELD to Parkview Drive.
 - h. Windrest Drive YIELD to Parkview Drive.
 - i. Recommends that STOP signs be installed on Winding Way at Kinser Pike and on Briarcliff and Kinser Pike.
- 2. Recommends STOP signs be installed on Bummitt at Cottage Grove. Cottage Grove to be preferrential Street.
- 3. Recommends a 'T' Intersection STOP sign on Monroe at Tenth St.
- 4. Recommends STOP signs on Fess at 14th. St.

- 5. Recommend two 15 minute parking spaces immediatly in front of Barge Baking Co. on N. I diana Ave.
- 6. Recommends that southbound ONE-WAY operation of Henderson St. Be extended from Second Sp. To First St.
- 7. Recommends that NO PARKING be permitted on the east side of South Fess from First St. to Maxwell.
- 8. Recommends that NO PARKING here to corner sign be installed on the south side of Eighth S., 30 feet from the east side of Jefferson. Also that a 'T' intersection STOP sign be installed to replace the present small STOP sign. In addition, a DEAD-END sign on standard post be installed on west side of Jefferson. A location for this sign is suggested a t a point approximately 25 feet west of pavement and slightly south of centerline of 8th. St. Eighth is unimporved west of Jefferson.
- 9. Recommends that the Council submit a resolution to the State Highway Dept. requesting installation fo 30mph signs on Fee Lane from Tenth St. to Seventeenth St.
- 10. Request for 4-way STOP at 5th. and Madison was studied by Traffic Commission and found unwarranted.

The recommendations contained in this report have been surveyed and studied by this committee and are approved as hereby submitted.
