

REGULAR MEETING

April 3, 1962

THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, met in the Council Chambers in City Hall, on Tuesday, April 3, 1962, at the hour of seven-thirty o'clock (7:30 P.M.) in regular session with Mayor Thos. L. Lemon presiding.

Members present: Sikes, Chitwood, Peace, Faucett, Hickman, and Shertzer.

Members absent: Graves.

Councilman Peace moved, seconded by Councilman Chitwood that the minutes of the last regular meeting of March 20, 1962 be approved as submitted to each individual councilman; motion unanimously carried.

Councilman Sikes presented Ordinance No. 8, 1962 for second reading. After second reading, Councilman Sikes moved, seconded by Councilman Peace that Ordinance No. 8, 1962 be duly adopted. After public hearing, upon a roll call vote Ordinance No. 8, 1962 was unanimously adopted.

Councilman Sikes presented Ordinance No. 9 for second reading. After second reading, Councilman Sikes moved, seconded by Councilman Chitwood that Ordinance No. 9, 1962 be duly adopted. After public hearing, upon a roll call vote Ordinance No. 9, 1962 was unanimously adopted.

Councilman Sikes presented Ordinance No. ~~10~~ 10, 1962 for second reading and moved, seconded by Councilman Peace that it be given second reading by title only. Upon a roll call vote the motion was unanimously carried. After second reading by title only, Councilman Peace moved, seconded by Councilman Sikes that Ordinance No. 10, 1962 be duly adopted. After public hearing, upon a roll call vote Ordinance No. 10, 1962 was unanimously adopted.

The Mayor read a petition to cut a curb from Edith Szatkowski which was turned over to the City Engineer.

The Abbutus Drive report was referred back to the Council Committee for further study and report at the next Council meeting.

Councilman Hickman moved, seconded by Councilman Faucett that the petition for increase in lamination be approved from the present lumen to the next higher lumen at the corner of Sixth and Waldron; motion unanimously carried.


Preliminary report was made by Councilman Sikes who stated that meetings have been held on the taxi-cab ordinance and report will be forthcoming.
