

REGULAR MEETING

August 16, 1960

THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, met in the Council Chambers in City Hall, on Tuesday, August 16, 1960, at the hour of seven-thirty o'clock (7:30 P.M. D.S.T.) in regular session with Mayor Thos. L. Lemon presiding.

Members present: Sikes, Peace, Graves, Faucett, Hickman, and Marxson.

Members absent: Chitwood.

Councilman Peace moved, seconded by Councilman Faucett that the minutes of the last regular meeting of August 2, 1960, be approved as submitted to each individual councilman; motion unanimously carried.

Councilman Sikes presented Ordinance No. 23, 1960 for first reading by the Clerk-Treasurer.

Councilman Sikes presented Ordinance No. 24, 1960 for first reading by the Clerk-Treasurer.

Dr. Ramsey spoke at length to the Council as to his personal objections to urban renewal.

Councilman Graves presented an oral petition from Mr. Gene Richardson for a street light at the intersection of First and Swain and moved, seconded by Councilman Peace that the petition be referred to the City Utilities Committee for investigation and report; motion unanimously carried.

Councilman Peace presented the following report from the Bloomington Traffic Commission and moved, seconded by Councilman Graves that this recommendation be approved as submitted; motion unanimously carried:

At the August 9, 1960 meeting of the Bloomington Traffic Commission, below listed traffic and related recommendations were adopted and are herewith submitted to the Mayor and Common Council for consideration and action:
