November 15, 1960

THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, met in the Council Chambers in City Hall, on Tuesday, November 15, 1960, at the hour of seven-thirty o'clock (7:30 P.M. C.S.T.) in regular session with Mayor Thos. L. Lemon.presiding.

Members present: Sikes, Peace, Graves, Chitwood, Hickman, and Shertzer.

Members absent: Faucett.

The meeting was opened with a prayer by Councilman Graves.

Councilman Chitwood moved, seconded by Councilman Peace that the minutes of the last regular meeting of November 1, 1960, be approved as submitted to each individual councilman; motion unanimously carried.

Councilman Sikes presented Ordinance No. 25, 1960 pertinent to the amending of the Municipal Code for second reading by the Clerk-Treasurer. After second reading by the Clerk-Treasurer, Councilman Graves moved, seconded by Councilman Chitwood that Ordinance No. 25, 1960 be duly adopted. Upon a roll call vote Ordinance No. 25, 1960 was unanimously adopted.

Councilman Sikes presented Ordinance No. 26, 1960 for second reading by the Clerk-Treasurer. After second reading by the Clerk-Treasurer, Councilman Graves moved, seconded by Councilman Chitwood that Ordinance No. 26, 1960 pertinent to the rezoning of property be duly adopted. Upon a roll call vote Ordinance No. 26, 1960 was unanimously adopted.

Councilman Sikes presented Ordinance No. 27, 1960 for first reading by the Clerk-Treasurer. After first reading, Councilman Sikes moved, seconded by Councilman Peace that Ordinance No. 27, 1960 pertinent to the amending of Ordinance No. 7, 1954 be advanced to second reading by title only. Upon a roll call vote the motion was unanimously carried. After second reading by title onlybythe Clerk-Treasurer, Councilman Chitwood moved, seconded by Councilman Sikes that Ordinance No. 27, 1960 be duly adopted. Upon a roll call vote, Ordinance No. 27, 1960 was unanimously adopted.

Councilman Graves presented a petition from Mrs. Agatha Heagy, 717 West First, for a street light at the corner of First and Fairview Streets. Councilman Graves moved, seconded by Councilman Peace that this petition be referred to the City Utilities Committee for investigation and report at next Councilmeeting; motion unanimously carried.

Councilman Graves presented plans and a map as prepared by the City Engineer and Mr. Kixmiller of Public Service Company of Indiana, Inc. and moved, seconded by Councilman Peace that these plans and map be referred to the City Utility Committee for future study and report at next Council meeting; motion unanimously carried.

Councilman Peace reported that the petition for a four-way stop at 11th and Rogers and 11th and Monroe had been referred to the Traffic Commission for study and report.

Reports for the month of October, 1960, were received and placed on file from the Police Dept., Fire Dept., and Water Dept.

Councilman Peace read the following recommendations from the Public Safety Committee of the Common Council and moved, seconded by Councilman Graves its adoption; motion unanimously carried.:

Report to Common Council From Public Safety Committee. Nov. 15, 1960

The Traffic Commission at the noon meeting, Nov. 14, 1960 Approved the following traffic recommendations.

"That parking be banned on both sides of East Third Street, extending from S. Righ St. to the By-pass."

The proposal has been studied by this committee and we believe that ample off street parking is available and that continuing use of this area for parking creates a serious traffic hazard and should be discontinued.

Therefore we recommend that the Council act on the recommendation of the Traffic Commission and that the Traffic Code be ammended accordingly.
