

REGULAR MEETING

May 19, 1959

THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, met in the Council Chambers in City Hall, on Tuesday, May 19, 1959, at the hour of seven-thirty o'clock (7:30 P.M. D.S.T.) in regular session with Mayor Thos. L. Lemon presiding.

Members present: Graves, Chitwood, Griffith, Miller, Peace, and Van Meter.

Members absent: Sikes.

The meeting was opened with a prayer by Councilman Miller.

Councilman Graves moved, seconded by Councilman Van Meter that the minutes of the last regular meeting be approved as submitted to each individual councilman.

Councilman Peace moved, seconded by Councilman Miller that the minutes be amended to read "City Utilities Committee" instead of Public Works Committee in the seventh paragraph; motion unanimously carried.

Councilman Graves moved, seconded by Councilman Chitwood that the minutes of the last regular meeting May 5, 1959 be approved as amended; motion unanimously carried.

Councilman Griffith presented Ordinance No. 5, 1959 for second reading by title only.

Councilman Griffith reported that the Board of Public Works and Safety had approved the recommendation of the Ordinance Committee of the Common Council to amend Ordinance No.5, 1959 as follows:

On motion of the City Engineer and seconded by the City Attorney, the following resolution was hereby adopted:

WHEREAS, the City Council has recommended that the resolution adopted by this Board under date of March 17, 1959, with reference to the salaries of the Mayor and Clerk-Treasurer from the Water Department and City Sanitation Department be amended and revised;

NOW, THEREFORE, BE IT RESOLVED, that said resolution be amended to read as follows:

BE IT RESOLVED, that there be paid to the Mayor and the Clerk-Treasurer from the funds of the City Water Department as compensation for services to the City Water Department the following amounts:

Mayor	\$1,000.00 per year
Clerk-Treasurer	\$1,000.00 per year

BE IT FURTHER RESOLVED, that there be paid to the Mayor and the Clerk-Treasurer from the funds of the City Sanitation Department as compensation for services to the City Sanitation Department the following amounts:

Mayor	\$1,000.00 per year
Clerk-Treasurer	\$1,000.00 per year

That said payments for said services be effective January 1, 1960, and to continue until changed by the Board of Works.

BE IT FURTHER RESOLVED, that from and after May 1, 1959, to and including December 31, 1959, that the Mayor be paid from the funds of the City Water Department the sum of One Hundred Sixty-six Dollars Sixty-seven Cents (\$166.67) per month, and from the funds of the City Sanitation Department the sum of One Hundred Sixty-six Dollars Sixty-seven Cents (\$166.67) per month for services to the said departments as compensation therefor, such compensation to be in addition to his statutory salary as Mayor.

Councilman Griffith moved, seconded by Councilman Chitwood that Ordinance No. 5, 1959 be amended as follows:

AMENDMENT

That Ordinance No. 5, 1959, be amended as follows:

In Section 1., opposite the word "Mayor", the figures "\$2,000.00" be stricken and the figures, "\$1,000.00" inserted; that opposite the words, "Clerk-Treasurer" the figures "\$1,500.00" be stricken and the figures, "\$1,000.00" inserted;

That Section 2 be amended by striking the figures opposite the word "Mayor" of \$2,000.00 and inserting therefor the figures, "\$1,000.00"; and by striking the figures opposite the words "Clerk-Treasurer" of \$1,500.00 and inserting therefor the figures, "\$1,000.00";

That a new section be added instead of the present Section 4, to read as follows:

"Section 4. From and after May 1, 1959, to and including December 31, 1959, the Mayor shall be paid from the funds of the City Water Department the sum of One Hundred Sixty-six Dollars Sixty-seven Cents (\$166.67) per month and from funds of the City Sanitation Department the sum of One Hundred Sixty-six Dollars Sixty-seven Cents (\$166.67) per month for services to the said departments as compensation therefor, such compensation to be in addition to the statutory salary as Mayor."

That Section 4 in the present Ordinance be stricken and Section 5 substituted therefor reading as follows:

"Section 5. This Ordinance shall be in full force and effect from and after its passage and approval by the Mayor."

Councilman Van Meter then moved, seconded by Councilman Miller that the amendment to Ordinance No. 5, 1959 as presented by Councilman Griffith be amended to read that the Clerk-Treasurer and Mayor receive \$600.00 from each utility as of January 1, 1960 instead of \$1,000.00 from each utility and that Section 4 of Ordinance No. 5, 1959 be deleted entirely.

After discussion the amendment to the amendment was defeated by roll call vote as follows:

Mayor Lemon asked for a roll call vote on Mr. Griffith's motion to amend Ordinance No. 5, 1959 and the amendment was passed as follows:

Councilman Griffith then moved, seconded by Councilman Chitwood that Ordinance No. 5, 1959 be adopted as amended. Upon a roll call vote Ordinance No. 5, 1959 was duly adopted with Councilmen Miller and Van Meter dissenting.

n Councilman Griffith moved, seconded by Councilman Chitwood that an ordinance with reference to voluntary annexation be given first reading and that the rules and regulations governing the first reading of Ordinances be suspended in order that Ordinance No. 9, 1959 could be introduced and given first reading as of this date. Upon a roll call vote the motion was carried with Councilman Graves dissenting. Councilman Griffith then introduced Ordinance No. 9, 1959 and same was given first reading by the Clerk-Treasurer.

Mayor Lemon appointed Councilman Griffith to serve as an enrollment committee of one for final approval of Ordinance No. 5, 1959.

Mayor Lemon reported on the condition of street lights on North Washington Street.C

Councilman Graves reported that the Public Works Committee had investigated the vacating of the alley between Grant and the first alley west running north and south between 9th and 10th as requested by the East Side Nazarene Church and moved, seconded by Councilman Miller that the City Attorney be instructed not to oppose the suit in Circuit Court as filed by Sylvan Tackitt, representing the Trustees of the East Side Nazarene Church as petitioned; motion unanimously carried.

Councilman Graves moved, seconded by Councilman Chitwood that the petition for the cutting of a curb for the purpose of a driveway as petitioned for by the East Side Nazarene Church be approved and the work be done under the supervision of the City Engineer; motion unanimously carried.

Norbert Peace presented the following Utilities Committee report:

After study, by the Utilities Committee of the Common Council, we move that the Common Council approve the Church Lane Water Line contract as proposed by the Church Lane residents and instruct the City Attorney to draft a formal contract for approval by the Board of Works and Safety and also draft a proper ordinance for ratification of the contract by the Common Council. Upon a roll call vote the motion was unanimously carried.

Councilman Griffith moved, seconded by Councilman Van Meter that Mr. Warren McGuire at 1400 South Lincoln be granted permission to cut the curb for the purpose of ingress and egress and the work to be done under the supervision of the City Engineer; motion unanimously carried.

Councilman Peace moved, seconded by Councilman Graves that the petition for a street light at the corner of Ninth and John Streets be approved and that the petition for a street light on Grant Street between University and Second Streets be denied; motion unanimously carried.

The following recommendation of the Traffic Commission was received:

On the west side of South Washington Street from Third Street south to the first alley the following parking restrictions: Two spaces on north (in front of Commercial Credit) be 15 minutes time limit and the balance of the parking spaces be limited to two hours.

Councilman Peace moved, seconded by Councilman Van Meter that the Traffic Schedule of the Traffic Ordinance be amended accordingly; motion unanimously carried.

The report of the Street Department for Clean-up, Paint-up, Fix-up Week was received and placed on file.

The report of the Fire Department for the month of April, 1959 was received and placed on file.

At the request of Councilman Graves a check was made as to the "no-parking" restriction on the west side of Indiana Avenue between 5th and 6th Streets. Street Commissioner Richardson advised that the work would be done the following morning or as soon as weather permitted.

Mr. Graves requested information as to the widening of Morton Street from 6th to 9th Streets. He was advised that the work had already

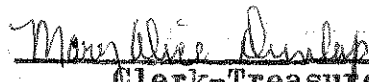
been done between 6th and 7th and that the project between 7th and 9th was on our schedule when time and materials were available.

Discussion was held concerning the laning of the street intersection at Third and Jordan.

Councilman Chitwood moved, seconded by Councilman Graves that the claim s be allowed as presented for payment May 20, 1959; motion unanimously carried.
