

July 15, 1958

THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, met in the Council Chambers in City Hall, on Tuesday, July 15, 1958, at the hour of seven-thirty o'clock (7:30 P.M. I.S.T.) in regular session with Mayor Thos. L. Lemon presiding.

Members present: Graves Chitwood, Griffith, Sikes, Miller, Simpson, and Van Meter.

Members absent: None.

The meeting was opened with a prayer by Rev. Robert Huber, Assistant Minister of the First Christian Church.

Councilman Sikes moved, seconded by Councilman Simpson that the minutes of the last regular meeting of July 1st be approved as submitted; motion unanimously carried.

Councilman Sikes moved, seconded by Councilman Simpson that Ordinance No. 14, 1958 be advanced to second reading by title only. Upon a roll call vote the motion was unanimously carried. After second reading by title only by the Clerk-Treasurer, Councilman Griffith moved, seconded by Councilman Chitwood that Ordinance No. 14, 1958 be duly adopted. Upon a roll call vote Ordinance No. 14, 1958 was unanimously adopted.

Councilman Griffith moved, seconded by Councilman Graves that Ordinance No. 15, 1958 pertinent to the rezoning of Lot No. 13, College Place Addition be advanced to second reading by title only. Upon a roll call vote the motion was unanimously carried. After second reading by title only by the Clerk-Treasurer, Councilman Griffith moved, seconded by Councilman Chitwood that Ordinance No. 15, 1958 be duly adopted. Upon a roll call vote Ordinance No. 15, 1958 was unanimously adopted.

Councilman Sikes presented Ordinance No. 16, 1958 pertinent to borrowing money for installment due on land purchase contract. After first reading by the Clerk-Treasurer, Councilman Griffith moved, seconded by Councilman Graves that Ordinance No. 16, 1958 be advanced to second reading by title only. Upon a roll call vote the motion was unanimously carried. After second reading by title only by the Clerk-Treasurer, Councilman Simpson moved, seconded by Councilman Chitwood that Ordinance No. 16, 1958 be duly adopted. Upon a roll call vote Ordinance No. 16, 1958 was unanimously adopted.

Councilman Sikes presented Ordinance No. 17, 1958 for first reading by the Clerk-Treasurer.

The petition for voluntary annexation by the Trustees of the Bloomington Metropolitan Schools was filed until next meeting.

Councilman Graves reported that the study of parking on West Eleventh and Indiana Avenue between Sixth and Seventh had not been completed and that a report would be made at the next meeting.

Councilman Griffith moved, seconded by Councilman Simpson that the action of the Board of Public Works and Safety in approving the Contract Supplement No. 1, Division 4, Golf Club House, Recreational Facilities, be ratified and approved by the Common Council; motion unanimously carried.
