REGULAR MEETING

April 9, 1954

THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, met in the Council Chamber in the City Hall on Tuesday, April 20, 1954, at the hour of seven-thirty o'clock p.m. (7:30 p.m.) in regular session with Mayor Kelly presiding.

Members Present: Carpenter, Donham, Griffith, McDaniel, Miller, Porter, and Ramsey

Members Absent: None

The minutes of the last regular meeting were approved on motion of Councilman Porter, seconded by Councilman McDaniel.

A request was received from the Kiwanis Club for further consideration by the Council of their interest in obtaining the site known as Leonard Springs for development as a recreation area. On motion of Councilman McDaniel, seconded by Councilman Miller, their request was referred to the Board of Public Works and Safety with power to act.

A letter was received from The Plan Commission as follows:

"To the Common Council of the City of Bloomington, Indiana

Gentlemen: The City Plan Commission of Bloomington, Indiana, wishes to inform the Common Council of Bloomington, Indiana, that a public hearing was held on April 8, 1954, to consider the rezoning of Lots Number 39 and 40, and 100 feet off of the East Side of Lots Number 41 and 42, all in Campus Place Addition to the City of Bloomington, Indiana. The hearing was held at the request of owner of said lots.

The Commission, after due deliberation, recommends that none of said Lots Number 39, 40, 41 and 42 in said Campus Place Addition be rezoned.

On motion of Councilman Miller, seconded by Councilman Porter, the petition for rezoning was rejected unanimously on a roll-call vote.

That she is the owner of the following described real estate, located East of Maxwell Manors Addition to the City of Bloomington, Indiana, and which is more particularly described as follows, to-wit:

> A part of the Northeast quarter of the Southwest quarter of Section Three (3), Township Eight (8) North, Range One (1) West, bounded and described as follows, to-wit: Beginning at the Southwest corner of the Northeast quarter of the Southwest quarter of said Section Three (3), Township and Range aforesaid, this point of beginning being also the Southeast corner of Maxwell Manors Addition to the City of Bloomington, Indiana; running thence East for a distance of Five Hundred Fifty (550) feet to a point; running thence North for a distance of Six Hundred Sixty and forty-five hundredths (660.45) feet to a point; running thence West for a distance of Five Hundred Fifty (550) feet to a point;
