

## REGULAR MEETING

Tuesday, October 19, 1954

THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, met in the Council Chamber in the City Hall on Tuesday, October 19, 1954, at the hour of seven-thirty o'clock P.M. (7:30 P.M.), in regular session, with Mayor Kelly presiding.

Members Present: Carpenter, Donham, Griffith, McDaniel, Miller, Porter, and Ramsey

Members Absent: None

The minutes of the last meeting were approved as read on motion of Councilman Porter, seconded by Councilman McDaniel.

The following recommendation was received from the Traffic Commission:

"TO: The Bloomington City Council 15 September, 1954  
FROM: Bloomington Traffic Commission  
SUBJECT: Recommendation, regarding intersection improvement.

Gentlemen:

In our meeting last night, Tuesday, 14 September, 1954, we had a motion by Mr. Harry Williams, seconded by Mr. Newt Gilmore, and carried by the members present, "to recommend the City Council ask the Indiana State Highway Commission to increase the width of the intersection of Grimes Lane and Walnut Street. This could be accomplished by opening the radius on each corner of the intersection."

The members of the Traffic Commission feel that this would, to some large degree, expedite the movement of traffic on this busy intersection.

Councilman Carpenter moved this recommendation be adopted and directed to the State Highway Department, requesting consideration of this matter; Councilman Donham seconded motion; motion carried.

A petition with seventeen signatures was received requesting the installation of a street light on the corner of East Smith Avenue and South Henderson Street. Councilman Miller reported this request had already been investigated by the Committee on City Utilities and with their approval, he moved that the installation of a street light at this location be authorized. Councilman Donham seconded motion; motion carried.

A petition presented by Lloyd C. Peters of 817 West Eleventh Street, on behalf of 220 persons who own property at the northwest area of Bloomington, requesting immediate consideration to the need for sewer service in this area, was acknowledged by the Council and directed to be placed on file on motion of Councilman Carpenter, seconded by Councilman Miller, with the comment that the proposed sewer expansion program now under consideration will include this area.

Councilman Ramsey commented in behalf of Ben R. Ross who has petitioned the Council for relief in connection with the charge made for his water service. On motion of Councilman Griffith, seconded by Councilman Ramsey, the petition was referred to the Council Committee on City Utilities.

On motion of Councilman Donham, seconded by Councilman Miller, the meeting adjourned.
