

REGULAR MEETING

Tuesday, March 3, 1953

THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, met in regular session in the Council Room in the City Hall, at the hour of seven-thirty o'clock P.M. (7:30 P.M.) on Tuesday, March 3, 1953, with Mayor Kelly presiding.

Members present: Carpenter, Fowler, Griffith, McDaniel, Miller, Porter, and Ramsey

The minutes of the previous meeting were approved on motion of Councilman Miller, seconded by Councilman McDaniel.

A letter received from Senator W. B. Hoadley in answer to the Council's request for favorable consideration of bills before the 1953 session of the State Legislature, advising that he would give these bills his careful consideration.

The report of J. N. Gilmore, Street Commissioner, for the month of February 1953 was accepted by the Council on motion of Councilman Fowler, seconded by Councilman Porter.

The report of the Sanitation Department for the month of February 1953, presented by L. M. Rogers, Superintendent, was accepted by the Council on motion of Councilman McDaniel, seconded by Councilman Ramsey.

The report of the Fire Department for the month of February 1953 presented by Horace Robertson, Chief, was accepted by the Council on motion of Councilman Porter, seconded by Councilman Griffith.

Councilman Miller, as Chairman of the Committee on Sidewalk and Street Lighting, advised the Council that Mr. F. B. Stimson, Manager of the Public Service Company of Indiana, Inc., recommended that the Street Light authorized on August 21, 1951, for the corner of Second Street and Eastside Drive, be placed at a different location than the original authorization. It is recommended that the light be placed at the southeast corner of the east jog of Second and Eastside Drive, instead of at the west jog of Second and Eastside Drive. Councilman Miller moved that the light be authorized installed under the supervision of Councilman Ramsey and that the installation be made immediately. Councilman Porter seconded the motion; motion carried.

Attorney James Register, representing M. C. Riley, Commissioner by Court Order to sell property located Northwest Corner of Eleventh Street and College Avenue, inquired if the Council would consider a petition for the rezoning of this area, if one were presented. The reason for this inquiry is that the sale of the property would be affected if it were possible that the area might be rezoned for business or manufacturing. After discussion, Councilman Fowler moved that the Council would consider rezoning of the property if such a petition were presented; Councilman Carpenter seconded the motion; motion carried.

The meeting adjourned on motion of Councilman McDaniel seconded by Councilman Miller.
