

REGULAR MEETING

Tuesday, August 21, 1951

THE COMMON COUNCIL MET in regular session in the Council Room at 7:30 o'clock P. M., on Tuesday, August 21, 1951, with Mayor Lemon presiding.

ROLL CALL:

Present -Black, Chitwood, Dunn, Parks, Shank and Woolery.  
Absent -Sikes

The minutes of the last regular meeting were read and approved as read upon motion by Councilwoman Woolery, seconded by Councilman Parks and carried.

PETITIONS

A petition was received from Chester L. Dunlap of 701 Hawthorne Drive asking permission to cut curb for a distance of twenty (20) feet. Councilman Chitwood moved the above petition be place in the hands of the Street Committee for study , with the power to act, seconded by Councilman Shank; carried.

Omen Sims of 1328 South Washington Street, filed a petition requesting permission to move a house 31x12, from the corner of Washington and Wilson Drive to 1300 Monon Drive a distance of three blocks. The route is as follows, from Washington and Wilson Drive, west to Walnut Street, North one block on Walnut, then West one block to Monon Drive. The mover John Gray. Councilman Shank moved this petition be placed in the hands of the Street Committee with the power to act, also Mr. Sims must furnish the City with insurance and bond required and comply with all other regulations of the City of Bloomington, seconded by Councilman Parks; carried.

Apetition from thirty one (31) property owners was received asking the City to designate an annual "rat Day" under the City Board of Health Department. Councilman Dunn moved this petition be referred to James Wray the City Sanitary officers for study and that he contact several of the signers of this petition and report back to the Council at the next regular meeting; motion carried.

Fred H. Howe sent a letter to the council resigning from the Bloomington School Board. Councilwoman Woolery moved his resignation from the School Board be accepted, seconded by Councilman Parks; Motion carried.

STREET LIGHT

Councilman Chitwood moved a street light be installed at the corner of Second and East Side Drive, seconded by Councilman Shank; Carried.

Councilman Chitwood nominated Hilbert Graves of 221 West Fourteenth Street, to fill out the unexpired term of Fred H. Howe on the School Board.

Councilman Dunn moved the nominations be closed, seconded by Councilman Parks, carried. Upon a roll call vote the vote was unanimous in favor of Mr. Hilbert Graves. Mr. Hilbert Graves is now a member of the Bloomington School Board.

CLAIMS

Councilman Black moved that claims n0. 2215 to 2378 inclusive, in the amount of \$29,002.83 be allowed and warrants ordered issued, seconded by Councilman Parks; carried.

Upon motion made by Councilwoman Woolery and duly seconded by Councilman Chitwood the meeting adjourned.
