

REGULAR MEETING

TUESDAY, OCTOBER 2, 1951.

The COMMON COUNCIL of the City of Bloomington, Ind. met in regular session in the Council Chambers on Tuesday, October 2, 1951, at 7:30 o'clock, P. M., with Mayor Lemon presiding.

Members Present: Chitwood, Dunn, Parks, Shank, Sikes and Woolery.  
" Absent: Black

The minutes of the last regular meeting were read and approved as read upon motion by Councilwoman Woolery, seconded by Councilman Sikes and carried.

PETITIONS TO CUT CURB:

An application for permission to cut the curb for a distance of 22 feet at the property at 435 South Walnut Street was received from C. R. Bartlett and Louise Bartlett, owners of said premises, in order to secure a better entrance for Bridgewater Motor Sales used car lot.

Councilman Shank moved this petition be referred to the Street Committee for study; seconded by Councilman Chitwood, motion carried.

An application for permission ~~from~~ to cut curb and replace sidewalk was received from Wm. R. Salmon of 614 N. College Ave. The curb is to be cut at the alley and 2 sections of sidewalk replaced for a radius of eight feet, an area of four feet by four feet, in order to secure entrance to his garage from the alley.

Councilman Chitwood moved this petition be placed on file as work has been completed. Motion seconded by Councilwoman Woolery and carried.

A petition was presented to the Council from Roy T. Wilson of 619 South Rogers Street, asking permission to cut curb for a distance of 13 feet, an area of 13 feet by 5 feet to secure better entrance to his place of business.

Councilman Shank moved this petition be granted, work to be done under the supervision of the City Engineer; seconded by Councilman Chitwood, motion carried.

A petition was presented from Anna and George Bridwell, 401 E. 10th St., asking permission to cut sidewalk for a distance of 35 feet, an area of 5 feet by 35 feet on Grant Street just off 10th St.

Councilman Dunn moved this petition be approved and work be done under the supervision of City Engineer; seconded by Councilman Chitwood, motion carried.

STREET LIGHT PETITIONS:

Petition was presented to the Council from Mr. P. Coia, asking that two street lights be installed at the corners of 3rd and Clark Sts. and 3rd and Roosevelt Sts.

Councilman Chitwood moved this petition be placed in the hands of the Light Committee for study and report back at next Council meeting. Seconded By Councilman Sikes, motion carried.

A petition was received from 21 property owners asking that a street light be installed at the corner of Park Ave. and Maxwell Lane.

Councilman Shank moved this petition be placed in the hands of the Light Committee for report at next Council meeting; seconded by Councilman Chitwood, motion carried.

A petition from 28 property owners was presented to the Council asking that street lights be installed for three blocks extending ~~from~~<sup>on</sup> West Allen Street~~to~~<sup>from</sup> the City Limits to Rogers Street.

Councilman Chitwood moved this petition be referred to the Light Committee for study and report be made at the next Council Meeting. Motion seconded by Councilman Dunn and carried.

PETITION TO OPEN ALLEY:

A petition from George A. Bailey and Frances E. Bailey was presented to the Council requesting the City to give them permission to open an alley at the rear of their property at 713 W. First Street.

Councilman Chitwood moved this petition be put in the hands of the Street Committee for study and report back at the next Council meeting. Motion seconded by Councilman Dunn and carried.

MONTHLY REPORTS:

Bernard Glover, Fire Chief, presented his report for the month of September, 1951. Upon motion by Councilwoman Woolery, seconded by Councilman Parks and carried, the report was accepted and ordered placed on file in the Clerk-Treasurer's office.

Glenn Marlin, Street Commissioner, presented his report for the month of September, 1951. Motion was made by Councilman Parks, seconded by Councilwoman Woolery and carried that the report be accepted and placed on file in the Clerk-Treasurer's office.


STREET LIGHT INSTALLATION:

Councilman Chitwood moved a street light be installed at the corner of Seventh and Clark Streets. Motion seconded by Councilman Sikes and carried.

CLAIMS:

Upon motion by Councilman Parks, Seconded by Councilman Chitwood, Claims Nos. 2622 to 2736, inclusive were approved and warrants ordered issued in the amount of \$34,294.63.
