

REGULAR MEETING

TUESDAY, OCTOBER 16, 1951.

The COMMON COUNCIL of the City of Bloomington, Indiana met in regular session in the Council Chambers on Tuesday, October 16, 1951 at 7:30 o'clock p. m., with Mayor Lemon presiding.

Members Present: Black, Chitwood, Dunn, Parks, Shank, Sikes and Woolery.
" Absent: None

The minutes of the last regular meeting were read and approved as read upon motion by Councilwoman Woolery, seconded by Councilman Chitwood and carried.

PETITION FOR STREET LIGHT:

A petition was presented from seven property owners requesting the City to install a street light at the corner of South Highland and Sheridan Road, and also at a point one-half block east of Sheridan Road where a road supr connects Sheridan Road to Southdown Avenue.

Councilman Chitwood moved this petition be turned over to the Light Committee for study and report at next Council meeting. Motion seconded by Councilman Sikes and carried.

STREET LIGHT INSTALLATIONS:

Councilman Chitwood moved that streetlights be installed at the following places: the corner of Third and Clark Streets, the corner of Third and Roosevelt Streets, the corner of Park Ave. and Maxwell Lane and on W. Allen Street three block west from Rogers Street. Motion seconded by Councilman Black and carried.

REPORT FROM STREET COMMITTEE:

Councilman Shank moved and Councilman Parks seconded the motion that C. R. Bartlett, 435 S. Walnut St., be permitted to cut the curb at that property for a distance of 22 feet. It was stated that permission from the State Highway Department had been received. Motion carried.

Mayor Lemon stated that a letter had been received stating that there were no street lights on South Mitchell Street. The Mayor recommended that the Light Committee look into this and report their findings to the Council members.

LETTER OF RESIGNATION:

Carl O. Stewart, Clerk-Treasurer, sent a letter to the Mayor and Common Council stating that he wished to resign from his position as Clerk-Treasurer in order to return to his job on the Monon Railroad.

Councilman Dunn moved the letter of resignation be accepted and placed on file in the Clerk-Treasurer's office. Motion seconded by Councilman Chitwood and carried.

APPOINTMENT OF CLERK-TREASURER.

Mayor Lemon presented the name of Mrs. Helen Zell for Clerk-Treasurer.

Councilwoman Woolery made a motion that Mrs. Zell be appointed as Clerk-Treasurer of the City of Bloomington, beginning October 17, 1951 at 12:00 o'clock noon. Motion seconded by Councilman Sikes and unanimously carried. Mrs. Helen Zell is now officially Clerk-Treasurer of the City of Bloomington.
