

REGULAR MEETING

SEPTEMBER 5, 1950

THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, met in regular session in the Council Chamber at 6:30 P. M., Central Standard Time, on Tuesday, September 5, 1950, with Mayor Lemon presiding.

Roll Call:

Present - Black, Chitwood, Parks, Dunn, Shank,

Absent - None

The minutes of the last regular and adjourned meetings were read and approved as read upon motion by Councilwoman Woolery, seconded by Councilman Sikes. Motion carried.

PETITIONS

A petition from Hillcrest Apartment, Inc., was presented to the Council asking permission to construct concrete curb and gutter and 5' sidewalk on west side of Fess Avenue.

Councilwoman Woolery moved the above petition be granted under the supervision of City Engineer. Seconded by Councilman Dunn, motion carried.

FIRE REPORT

Chief Glover gave his fire report for the month of August. Councilman Black moved this report be approved and placed on file in the City Clerk-Treasurer's office. Seconded by Councilman Chitwood, motion carried.

Committee

Councilman Shank moved the Street ~~Committee~~ and the Council meet with Sarkes Tarzian on Thursday, September 7, 1950, to discuss vacating an alley abutting his property. The Street Committee has power to decide whether they wish to have the City Attorney oppose the suit. Seconded by Councilman Dunn, motion carried.

Proofs of Publication were presented to the Council, showing that the Council would consider Special Appropriation #3, 1950 on this day, September 5, 1950.

Councilwoman Woolery moved Special Appropriation Ordinance #3, 1950 be adopted as follows:

ORDINANCE OF THE CITY OF BLOOMINGTON,
COUNTY OF MONROE, STATE OF INDIANA,
SPECIAL APPROPRIATION No. 3, 1950

An Ordinance specially appropriating from the general funds of the City of Bloomington, Monroe County, Indiana, not otherwise appropriated and appropriating said sums to the following funds in the following departments of said City, and transferring from the funds of the department of said City hereinafter named, heretofore appropriated to said department and appropriating said sums to the following funds of said department of said City, to meet the extraordinary emergency found to exist for the various purposes more specifically set out in said Ordinance.

Be It Ordained, by the Common Council of the City of Bloomington, Monroe County, Indiana:

Section 1: That there be, and hereby is, appropriated from the general funds of said City, not otherwise appropriated, to meet the extraordinary emergency found to exist for the expenditure of more money for the current year, 1950, than was set out in detail in the

budget as finally adopted and appropriations as finally made, the following sums to the following funds in the following departments of the City of Bloomington, Indiana:

1. Bruner Courts

- (a) 2 Services Contractual; 22 Heat, Light, Power and Water; 221 and 222 Electric Current and gas \$ 800.00

The emergency which requires the additional appropriation in the above item came about as a result of the fact that on November 1, 1949, the City of Bloomington took over from the United States Government the management, including the receiving of the income and the paying of the debts, of Bruner Courts, a veterans' housing facility located south of the City of Bloomington. For this reason it was impossible to anticipate, when the 1950 budget was prepared, that there should be included in the 1950 budget electric current and gas bills which would have to be paid out of the 1950 budget.

- (b) 2 Services Contractual; 25 Repairs; 251 Repairs of Building and Structures \$ 254.80

The emergency which requires the additional appropriation in the above item was brought about by reason of the fact that in August, 1948, certain construction was done in Bruner Courts involving an expenditure of \$254.80. This expenditure was made out of the funds of the Department of Sanitation and during the year, 1950, the State Board of Accounts, in an audit, refused to approve this expenditure and ordered the civil city to reimburse the Department of Sanitation with this sum. This decision, and the necessity for such reimbursing, was not known, and could not have been known, when the 1950 budget was prepared.

2. Rosehill Cemetery

- (a) 2 Services Contractual; 22 Heat, Light, Power and Water; 224 Water \$ 75.00

The emergency which requires the additional appropriation in the above item was brought about by reason of the fact that there was installed, during 1950, an additional water meter in Rosehill Cemetery, which installation was not anticipated when the 1950 budget was prepared.

3. Police Department

- (a) 3 Supplies; 33 Garage and Motor; 334 Other Garage and Motor Supplies \$ 400.00

The emergency which requires the additional appropriation in the above item was brought about by reason of the fact that more garage and motor maintenance has been required during the year, 1950, than was anticipated when the 1950 budget was prepared.

- (b) 3 Supplies; 34 Institutional and Medical; 341 Clothing and Household \$ 433.14

The emergency which requires the additional appropriation in the above item was brought about by reason of the fact that during 1950 there was employed by the Police Department three additional members of the police force and when the 1950 budget was prepared it was not taken into account that there would have to be, by law, supplied to each of these new officers clothing costing 144.38 for each officer, a total of \$433.14.

4. Fire Department

- (a) 2 Services Contractual; 21 Communication and Transportation; 214 Telephone and Telegraph \$ 50.00

The emergency which requires the additional appropriation in the above item was brought about by reason of the fact that since the preparation of the 1950 budget there has been an increase in telephone rates.

- (b) 3 Supplies; 33 Garage and Motor; 331 and 332 Gasoline and Oil \$ 250.00

The emergency which requires the additional appropriation in the above item was brought about by reason of the fact that since the preparation of the 1950 budget, there was purchased two large pieces of motor equipment for use by the Fire Department, requiring an additional outlay for gasoline and oil to propel and service same.

- (c) 3 Supplies; 33 Garage and Motor; 334 Other Garage and Motor Supplies \$ 100.00

The emergency which requires the additional appropriation in the above item was brought about by reason of the fact that there have been emergency repairs and replacements not anticipated when the 1950 budget was prepared.

5. City Administration

- (a) 2 Services Contractual; 26 Services, Other Contractual; 261 - Painting Done in Police Department in 1947 \$ 335.00

The emergency which requires the additional appropriation in the above item was brought about by reason of the fact that in the year, 1947, certain painting was done in the police headquarters in the City Hall involving an expenditure of \$335.00. This expenditure was made out of the funds of the Department of Sanitation and during the year, 1950, the State Board of Accounts, in an audit, refused to approve this expenditure and ordered the civil city to reimburse the Department of Sanitation with this sum. This decision, and the necessity for such reimbursing, was not known, and could not have been known, when the 1950 budget was prepared.

- (b) 2 Services Contractual; 26 Services, Other Contractual; 263 - Court Costs \$ 150.00

The emergency which requires the additional appropriation in the above item was brought about by reason of the fact that a sale of surplus property is being held during 1950 which will gross for the civil city many thousands of dollars but from which gross proceeds there cannot be allocated any sums for payment of court costs. Such surplus property sale was not anticipated when the 1950 budget was prepared.

- (c) 7 Properties; 72 Equipment; 726 Other Equipment - New Furnace for City Hall \$1,700.00

The emergency which requires the additional appropriation in the above item was brought about by reason of the fact that the present heating plant for the City Hall wore out during the winter of 1949-1950 and cannot be repaired, and it was not anticipated when the 1950 budget was prepared that the heating plant would be rendered useless by the end of the 1949-1950 heating season.

6. Board of Park Trustees

- (a) 6 Current Obligations; 61 Interest - Interest on \$5,000.00 note \$ 125.00

The emergency which requires the additional appropriation in the above item was brought about by reason of the fact that during the year, 1949, the Board of Park Trustees borrowed \$5,000.00 needed in order to continue its operations and although proper provision was made for the repayment of the principal of this sum there was, by oversight, omitted in its 1950 budget any provision for the payment of interest.

7. Board of Health

- (a) 1 Services Personal; 11 Salaries and Wages, Regular - Milk Inspector \$1,333.35

- (b) 2 Services Contractual; 26 Services, Other Contractual; 261 - Car Allowance for Milk Inspector \$ 185.00

The emergency which requires the additional appropriation in the above two items was brought about by reason of the fact that when the 1950 budget was prepared it was not anticipated that during the year, 1950, there would be a Grade A Milk Ordinance and since there was, during 1950, a Grade A Milk Ordinance adopted necessitating the employment of a Milk Inspector with allowance to such Milk Inspector for car expense. It was impossible to anticipate the above two items when the 1950 budget was prepared.

Section 2: That there be, and hereby is, transferred from the funds of the department of said City hereinafter named, heretofore appropriated to said department, and appropriating the sums to said department of said City to meet the extraordinary emergency found to exist, for the expenditure of more money for the current year, 1950, than was set out in detail in the budget as finally adopted and appropriations as finally made, the following sums to the following funds in said department of the City of Bloomington, Indiana:

1. From, Board of Park Trustees:

(a) 7 Properties; 72 Equipment; 726 Other Equipment \$ 200.00

To the following fund of Board of Park Trustees:

(a) 2 Services Contractual; 22 Heat, Light, Power and Water; 221 Electric Current \$ 200.00

The emergency which requires the transfer and additional appropriation in the above items was brought about by reason of the fact that there was greater activity in the city park system in connection with night recreational facilities which necessitated the use of more illumination and the consequent greater consumption of electrical current than was anticipated when the 1950 budget was prepared.

Section 3: This Ordinance shall be in full force and effect from and after its passage by the Common Council and its approval by the Mayor, subject to the approval of the same by the State Board of Tax Commissioners.

Passed and adopted by the Common Council of the City of Bloomington, Indiana, this 5th day of September, 1950.
