

The COMMON COUNCIL met in regular session in the Council Chamber on Tuesday, October 17, 1950, at 7:30 o'clock P. M., with Mayor Lemon presiding.

Roll Call:

Present: Black, Chitwood, Dunn, Shank, Sikes.
Absent: Woolery, Parks.

The minutes of the last regular meeting were read and approved as read upon motion of Councilman Dunn, seconded by Councilman Chitwood and carried.

PETITIONS:

An application for permission to cut curb for a distance of 15 feet at 1126 East First Street was presented to the Council from E. B. Duane.

Councilman Shank moved the above petition be granted provided the work is approved by City Engineer. Seconded by Councilman Black, motion carried.

A letter from Gale Baugh was presented asking permission to move a house from 231 Sunrise Drive to Lots 12 and 13, Block O, HighlandHomes Addition on North Jefferson Street.

Councilman Chitwood moved the route be investigated by Street Committee and they be given power to act on petition as case may be. Seconded by Councilman Shank, motion carried.

STREET REPORT

Glenn Marlin presented Street Report for September. Upon motion by Councilman Shank, seconded by Councilman Black and carried, the report was approved and ordered placed on file in Clerk-Treasurer's office.

Councilman Sikes introduced Resolution No. 8 as follows:

Resolution No. ³8, 1950, of the City of Bloomington Plan Commission, Relating to a Proposed Ordinance No. 19, 1950, "An Ordinance Providing for the Control of the Subdivision of Land and the approval of Plats and Replats of Land, Within the Jurisdiction of the Bloomington City Plan Commission, as a Part of the Master Plan for the City of Bloomington, Indiana."

WHEREAS, notice of public hearing has been given according to the terms of Chapter 174 of the Indiana Acts of 1947, a copy of which notice is attached to this resolution, and

WHEREAS, a public hearing was held on May 11, 1950, pursuant to such notice and an opportunity was given to all interested citizen to appear and present their views on the proposed ordinance, and

WHEREAS, the City of Bloomington Plan Commission has held the required hearing, considered the views expressed by interested citizens, and reviewed the proposed ordinance in the light of those suggestions, and with these alterations unanimously approved the proposed ordinance, now:

BE IT RESOLVED BY THE CITY OF BLOOMINGTON PLAN COMMISSION, That:

Section 1. The said City Plan Commission transmit to the Common Council of the City of Bloomington at its next regular meeting the attached ordinance with the recommendation that it do pass.
