## I. ROLL CALL

- II. READING OF THE MINUTES Mary Alice Rickert moved to approve the September 3, 2019, minutes. Sue Sgambelluri seconded the motion. The board unanimously approved.

Vickie Provine will be hosting a drop in session at the Monroe County Public Library on September 21, 2019, from 10am to 1pm. She will be talking about ways to contact the city through internet and different departments. Provine can also help citizens maneuver the city website and explain how to use the citywide u-report system, which is the system used to file complaints electronically.

Sims asked the commissioners for volunteers to serve on the Citizens Advisory Committee, as the Redevelopment Commission's representative for physical improvements and social services. Eric Sandweiss volunteered to serve on the physical improvements committee and Sue Sgambelluri volunteered to serve on the social services committee.

Sue Wanzer is the MCCSC school boards appointment to the Redevelopment Commission. Wanzer has resigned from her position on the commission. A replacement will be discussed at the next school board meeting.

**B.** Legal Report. Larry Allen stated last Monday the Planning Commission approved the site plans for the Trades District Garage. He said final site plans will be presented to the RDC for review and approval, in the near future. Allen said site plans for the 4<sup>th</sup> Street Garage will hopefully go back to the planning commission for review around December.
