**Proposed Amendment:**

1. App Ord 20-07 shall be amended by adding the word “Fund” after the words “Cumulative Capital Development” in the sixth Whereas Clause on the first page of the ordinance so that it will read as follows:

WHEREAS, the Public Works Department desires to transfer funds from Classification – 2 Supplies to Classification - 3 Other Services in its budget for the Cumulative Capital Development Fund; and

2. App Ord 20-07 shall be amended by adding the word “funds” after the words “desires to transfer” and by deleting the words “its budget in” in the eighth Whereas Clause on the first page of the ordinance so that it will read as follows:

WHEREAS, the Public Works - Fleet Maintenance division desires to transfer funds from Classification 4 – Capital Outlays to Classification – 1 Personnel Services and Classification – 2 Supplies in the Fleet Maintenance Fund not included in the adopted budget; and

3. App Ord 20-07 shall be amended by adding the word “funds” after the words “desires to transfer” and by deleting the words “its budget” in the tenth Whereas Clause on the first page of the ordinance so that it will read as follows:

WHEREAS, the Police Department desires to transfer funds from Classification – 3 Other Services to Classification 1 – Personnel Services in the Police Pension Fund not included in the adopted budget; and

4. App Ord 20-07 shall be amended by changing the word “Sustainability” to “Sustainable” in the reference to the Economic and Sustainable Development Department on the third page of the ordinance.

5. App Ord 20-07 shall be amended by changing the word “Alternate” to “Alternative” in the reference to the Alternative Transportation Fund on the fifth page of the ordinance.

**Proposed Amendment:**

1. App Ord 20-07 shall be amended by increasing the amount appropriated for Classification – 1 Personnel Services in the Solid Waste Fund from \$30,000 to \$55,000 and by increasing the amount appropriated for Classification – 3 Services and Charges in the Solid Waste Fund from \$20,000 to \$95,000. The grand total for the Solid Waste Fund and the grand total for all funds shall be revised to reflect the increases. The amount listed after Grand Total Solid Waste Fund shall be amended from \$30,000 to \$130,000. The amount listed after Grand Total All Funds shall be amended from \$1,530,400 to \$1,630,400.

**Synopsis**

This amendment is sponsored by Cm. Piedmont-Smith at the request of the Controller's Office. It increases the amount appropriated for Classification 1 – Personnel Services in the Solid Waste Fund from \$30,000 to \$55,000 and for Classification 3 – Services and Charges in the Solid Waste Fund from \$20,000 to \$95,000.

Gross impact is \$1,630,400 from four funds; General Fund-871,400, Sanitation Fund-130,000, Risk Management Fund-397,000 and the Rental Inspection Fund-232,000. Net impact is \$452,400.
