Two Ordinances Ready for Second Reading But No Ordinances Ready for Introduction at Regular Session on Wednesday, October 29th - A Fifth Wednesday

However, by meeting next week, the Council is able to set aside evenings for each of the four meetings for the two legislative cycles in November, without meeting the night before Thanksgiving. 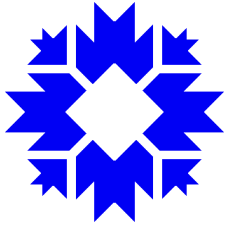
