

12:40 Q&A / Discussion: clarification of consensus vs. compromise, moral/ethical assumptions in Aorta, clarification on timeline following an official block to consensus, clarification on discussion process for whole commission when working groups bring forth proposals, clarification from city staff that CAPS can use a non-oppressive system, clarification that process of working groups can remain transparent to the public, discussion of public-facing working group processes and public participation in commission meetings or even in consensus building, discussion of how agendas will be determined in a non-oppressive system, discussion of structures like time limits for individual speaking turns during discussion or Q&A, discussion of possibility of social media presence for CAPS.

INTRODUCTION AND ROLL CALL

APPROVAL OF MINUTES FROM 8/26 MEETING: motion made, 2nded, and unanimously approved.

12:18 INTRODUCTION: Commissioner Johnson introduces Jada Bee, member of Core Council at BLM Bloomington and co-founder of The Peoples' Market.

12:20 PRESENTATION by Jada Bee:

- -The prejudices that challenge pioneering into a space, for ex: as a Black speaker at this commission
- -Layla Saad's definition of White Supremacy as the dominant paradigm in our culture, not a fringe belief
- -White privilege is separate from, but can intersect with, other privileges
- -BLM Bloomington core council and Peoples' Market wer able to begin with non-hierarchical systems because they first understood white supremacy
- -Hate speech vs. Free speech: hate speech is often acted upon
- -Edgar Villanueva's Decolonizing Wealth Project as a manual for orgs: https://decolonizingwealth.com/
- -Disproportionate amount of white people still hold most positions of power behind the scenes: who decides what TV shows or music are available to watch and listen to? Who are our teachers?
- -Jada shared her credentials as an anti-racist activist confronting White Supremacy
- -People of color are questioned on a daily basis about their competency despite their credentials
- -History of BLM Bloomington
- -BLM Bloomington decided to establish Working Agreements after it was necessary to remove a member of the core council
- -Working Agreements are based on the 13 Guiding Principles of National BLM anda rejection of Command-and-Control approach
- -Agreement within BLM core council is based on consensus-building
- -Each consensus is evaluated through the lens of how do the different viewpoints support or threaten the Working Agreements and Guiding Principles

- -As a multi-racial org, Peoples' Market formation faced different challenges than BLM Bloomington
- -Loving Engagement vs perception of "Being Mean" in holding everybody accountable to the mission goals and values
- -Explicit voting system part of non-hierarchical structure
- -How to Move Through Conflict is an explicit process agreed upon by members.

Meetings start with conflict resolution and/or restorative justice proposals

- -Working Agreements as how things are actually run vs. Bylaws which are a legal requirement
- -You can still prioritize voices that are traditionally marginalized in a horizontal structure
- -The "Rule of 33" in space creation: "Diversity" is often code for Tokenism. Representation for (white) women does not equal diversity
- -Jada suggested holding the current empty seats on CAPS for non-whites only
- -CAPS needs to "head-hunt" for people of color
- -Horizontal structures work best when there is racial parity
- -Reading up on and studying Anti-Racism is necessary, but not simply in an academic vacuum
- 1:46 Q&A SESSION with Jada
- 1:56 Commissioner Miller offered a time-check
- 2:00 Madison Cox, journalism student at IU, asked for Jada's contact info for a follow-up on a story for class
- 2:02 Jada's final piece of advice to CAPS: achieving racial parity on the commission should be prioritized over establishing Bylaws and starting our work
- 2:09 Motion to schedule next work session approved for Oct 14
- 2:13 Meeting adjourned

CAPS Commission Meeting | October 28, 2021

Staff Memo

In an effort to support the CAPS Commission's work, Council staff has put together some information that the Commission might want to consider at the October 28th Regular Session.

Agenda

Order of Business

Under local code, Robert's Rules of Order serves as the parliamentary authority for all commission meetings. Robert's provides a standard order of business for regular meetings:

- 1) Reading and Approval of Minutes
- 2) Reports of Officers, Boards, and Standing Committees
- 3) Reports of (Select or Ad Hoc) Committees
- 4) Special Orders
- 5) Unfinished Business and General Orders
- 6) New Business

Some of these headings may not be relevant to the work of the commission, while the Commission may wish to add other headings for each meeting. In order to better facilitate discussion and help Council staff and Commission members prepare for meetings, a suggested agenda template and order of business has been prepared for your consideration. The headings included in the attached draft agenda can be reordered, removed or amended at the Commission's discretion. Staff will be happy to discuss this in more detail on October 28 as needed.

Process for Placing Items on the Agenda

As you can see on the proposed agenda template, there could be multiple ways for commission members to propose items for action/topics for discussion. These opportunities could arise under the headings *Adoption of Agenda* (when the agenda is subject to amendment), *New Business, Other Business*, and/or *Topic suggestions for future agendas*. Council staff can assist with preparing and distributing the agenda before each meeting. Ultimately, it is a majority of the commission that has authority to decide what topics are taken up and discussed.

Committees

At the October 14th Work Session, commissioners discussed the creation of 4 committees: Housing, Reparations & Atonement, Conflict Resolution, and Crisis Intervention/Police Alternatives. A table of these possible committees and member assignments is attached to this memo.

Need to Formalize Committees and Appoint Members

Because the Commission indicated a preference for the creation of official committees rather than more ad hoc working groups, a vote is necessary to formalize their creation. This will require a motion and a second along with a majority roll call vote. Should the motion pass, the Commission can appoint members

to each committee. The Commission might want to discuss committee goals/purposes and term lengths as well.

Public Committee Meeting Requirements

Meetings of such committees should be conducted as public meeting and will be subject to the Indiana Open Door laws. As such, compliance requires:

- A notice be posted at least 48 weekday hours in advance, which can be done by staff;
- A written record with a "meeting memo", which should include the date and time the meeting started/ended, a list of members present/absent, a record of all motions and votes, and a description of the topics/items discussed. For reference, an example memo is included in this packet.
- The meeting itself must be open to the public, who must be able to attend, observe and record what transpires.

Council staff may not be available to attend all Committee meetings, so each Committee should be prepared to host its own online meeting through a virtual meeting platform, either with a separate Zoom account (free account has a 40 minute time limit) or through <u>Google Meet</u>, a free video conferencing service (free account has 60 minute time limit) which is available with a Gmail account. Or for in-person meetings, a meeting place must be secured in advance so it can be included in the notice. If a Committee prefers to meet at City Hall, staff can arrange a room. In addition, one member should be chosen to write up the meeting memo and email it to staff for posting.

Scheduling

Due to the public meeting requirements, if Committees plan to meet regularly, it might be most efficient to develop a regular schedule for Committee meetings.

In addition, Council staff can assist the Commission in creating an annual schedule for 2022.

May of 2022

One of the enumerated duties of the Commission is to provide an annual report of its activities to the Common Council, the Mayor, and the public. This report can be in the form of a presentation to the Council or a written report. The Commission may want to plan for a report sometime around May 2022. The Commission has broad authority to provide the information it deems relevant.

May of 2023

Ordinance 20-20, which created the CAPS Commission, states that the need for and efficacy of the Commission shall be reviewed by the Common Council two years after the Commission's first meeting. The CAPS commission met for the first time on May 18, 2021 so it is subject for review as early as May 2023.

Public Comment

There was some discussion at the October 14th work session about allowing public comment at meetings. The Commission is not required to allow the public to comment, only to attend, observe and record what transpires. However, if the Commission does decide to allow public comment, it has some flexibility to impose rules that are content neutral and treat each commenter equally. Some possible rules include establishing a time limit on speakers, limiting comments to agenda items, or only hearing public comment before the Commission takes final action (e.g., votes on a resolution or recommendation).

Commission Membership

New Member

On October 20, 2021, the Common Council appointed Eliza Carey to the CAPS Commission, with her term expiring on January 31, 2023. Staff will provide Ms. Carey with an onboarding welcome packet and will invite her to the October 28th regular session. An updated contact sheet is included in this packet.

Resignation

Commissioner Wunrow submitted his resignation from the Commission on October 25, 2021. When a vacancy occurs, the City Clerk's Office sends an announcement to the local media to alert the public to the vacancy and provide instructions on how interested individuals can apply.

Pending Removal of Inactive Member

Per the request of CAPS Commission interim co-chair Renee Miller and Council Public Safety Committee chair Jim Sims, Commissioner Mathew Diaz was contacted on October 19, 2021 regarding his pending removal from the Commission. Mr. Diaz has until October 26, 2021 to respond with any extenuating circumstances that may have prevented his participation thus far. If we receive no response, the Public Safety Committee can recommend his removal from the Commission to the full council at its next regular session. Staff will keep Commissioners informed of the results.

Other Information

GroupMe App

At the October 14th work session, staff was asked to evaluate the GroupMe app as a potential communication tool for the Commission. After some investigation, staff does not recommend the use of this tool for two reasons. First, the app is designed for group chatting and Commissioners are cautioned that simultaneous conversation between more than 4 members could violate Indiana Open Door laws. And second, while it appears that conversations can be exported and saved if necessary, the process is manual and time consuming.

Reminder

The current executive order allowing for virtual public meetings is set to expire at the end of October unless the Governor extends it. Commission members should be prepared to begin attending in-person meetings in November unless notified otherwise.

It could also allow for public comment only when the Commission is voting on taking a formal action (e.g., making recommendations to the Common Council/Mayor). Rules pertaining to public comment should be content neutral)
- 8. Unfinished Business (Includes old and ongoing business)
- 9. New Business (Includes new topics for discussion/new motions for consideration)
- 10. Other Business/Good of the Order (Gives Commissioners an opportunity to discuss non-agenda items relevant to the general welfare of the commission)

- 11. Topic suggestions for future agendas (Allows Commissioners input into future agenda topics and helps provide guidance to commission members/staff as to what materials may be needed at the next meeting)
- 12. Scheduling for next meetings (Confirm work sessions and/or committee meetings)
- 13. Adjournment
