Created by former Council member Jack Hopkins in collaboration with his Council and community colleagues in 1993, this marks the Committee's 30th year. The purpose of Tuesday's meeting is to plan the 2022 funding program. Please bring your calendars. The below provides a brief review of the Hopkins process and highlights issues for this year's Committee.



JACK HOPKINS FUNDING - PAST & PRESENT

In 2022 the Committee has \$317,000 in budgeted funds to distribute. The following reflects the growth of the fund since its inception.



NOTE: The increase of funding in 2020 & 2021 was due to the COVID-19 Recover Forward initiative.

ABOUT JACK HOPKINS FUNDS

- Unused 2021 funds may be available upon additional appropriation. The final amount will not be known until final claims are received, due on 25 March 2022.
- The non-reverting Jack Hopkins Fund, created in 2017, means that any unused funds will be available for future use by the Jack Hopkins Committee and will not revert to the City's General Fund at the end of the year.
- While this is a non-reverting fund, any unused money must still be appropriated into the Jack Hopkins Fund. As with any appropriation ordinance, State law requires that the City executive propose the appropriation ordinance.

ASSESSING THE 2021 PROGRAM

The Hopkins program is assessed at the end of each funding cycle through three vehicles: a Committee debriefing meeting; an applicant survey; and self-reports submitted to the City's HAND department upon the submission of an agency's final claim.

- In 2021 the Committee distributed \$511,000 among 32 projects.
- Survey responses for 2021 are detailed in the Survey Report contained in this packet.
- Most of the agency self-reports are included in the HAND Report from Cody Toothman.

CHANGES FOR 2022

The Committee held its debriefing meeting on May 27, 2021 and approved 2 significant changes to the Jack Hopkins process and directed Council staff to create a budget template for applicants.

- Operational Funding Requests Since 2016, the Committee has recognized that the local, state, and national economic climate has made it difficult for agencies to secure operational funding. Because operational funding is crucial to a non-profit's continued provision of essential services, the Committee accepted funding requests for operational expenses from agencies on a year-to-year basis. At the end of the 2021 funding cycle, the Committee voted unanimously to change the Elaboration of Criteria to accept operational requests on a permanent basis.
- <u>Limitation on Claims for Salary and Personnel</u> The Committee added a proviso to the Elaboration of Criteria that prohibits Jack Hopkins funds from being used for paid time off and bonuses.
- <u>Project Budget Template</u> Council Staff created a basic budget template for agencies to submit with their applications which is included in this packet.

ISSUES TO ADDRESS

Since the Committee last met in May of 2021, several issues have arisen that require clarification ahead of the 2022 grant cycle.

• How specific should the "Use of Funds" be in the funding agreement? Some agencies submit very detailed requests while others are more generalized. These requests are then included in the agencies' funding agreements which dictates how their Jack Hopkins funds can be spent. For example, one agency may request funds for "operations, supplies and staffing" (Boys & Girls Club, 2021) while another may request "24 weeks of salary support for a therapist and trauma

- training" (Catholic Charities, 2021.) The Committee may wish to provide additional guidance to agencies on the specificity of their funding requests in order to avoid any inequitable results.
- <u>Guidelines for Modifying the Use of Funds</u> In September of 2021 Habitat for Humanity found
 that the equipment they requested came in under their expected budget and asked to use the
 remaining funds to purchase an augur (lawn equipment.) The Committee might want to create
 guidelines for HAND staff when an agency requests a modification to their "use of funds" in the
 funding agreement.
- <u>Claims for Expenses Incurred before JH Allocation Date</u> In 2021 a few agencies submitted claims to the HAND department for expenses incurred before the Council passed <u>Resolution 21-19</u>, authorizing the allocation of Jack Hopkins funds on June 16th. The Committee may wish to define the parameters for the timing of allowable expenses.
- <u>Agency Presentations</u> In 2022, should agencies expect to present to the Committee in person (assuming the emergency order is lifted by then) or can they choose to present over Zoom?
- <u>Budget Template (draft)</u> At the request of the 2021 Jack Hopkins Committee, Council staff created a template for agencies to use when submitting the required project budget with their application.
 - o Does the Committee wish to make modifications to the template?
 - Should the budget template be a component of the application or just provided as a guide for agencies?

NEXT STEPS

- <u>Solicitation</u> Council staff will notify agencies of the start of the 2022 grant cycle by emailing community organizations, issuing a press release, posting to the Jack Hopkins website and submitting the information to the United Way's Non-Profit Alliance newsletter.
- <u>Technical Assistance for Applicants</u> Council staff will hold a meeting to review the grant process and answer any agency questions.
- <u>Initial Application Review Meeting</u> The Committee meets to review and discuss all applications, raise questions for agencies to answer, disclose conflicts of interest, and eliminate some applications from further consideration.
- <u>Agency Presentations</u> Competitive agencies will be invited to present their proposal and answer any questions that the Committee might have.
- <u>Pre-allocation Meeting</u> Committee members submit a recommended allocation amount and comments for each proposal before the meeting which will then be discussed.
- Allocation Hearing Formal allocation recommendations are made and the public is invited to comment.

Subject: Social Services Funding

Most of us have discussed the question of social services funding, either in the Social Services Committee (which has met twice) or individually. I would like to summarize the discussions of the committee so far, in order that we may act soon to take final action on the matter.

The committee reached a consensus on the following criteria to be used for choosing appropriate programs for funding in the 1993 budget year:

- 1. The focus should be on previously identified priority areas.
- 2. Programs or projects should be such that a one-time investment will make a substantial difference.
- 3. Priority should be given to projects or programs where investments now will have a positive long-term spillover effect (such as reduced susceptibility to other diseases, decreased absences from school, reducing lost time for sick child care, etc.)
- 4. Capital should be leveraged wherever possible by watching from other sources.

The Social Services committee concluded that the Community Heath Program meets all these criteria. Appropriation of the available 1993 social services funds for the Public Heath Nursing Association would enable the PHNA to carry out a drive for complete immunization of all children in Bloomington and Monroe County and enable the consolidation of three separate locations into one building, which would save substantial funds in the process. The possibility of leveraging the investment through Community Foundation's Lilly Endowment grant is being pursued. In addition, a substantial additional appropriation from Monroe County makes the Bloomington investment particularly timely and effective.

I would appreciate your comments before any final action is taken to introduce an appropriation ordinance for this purpose.


2021 Jack Hopkins Agency Survey Responses

Introduction:

All agencies that submitted an application for Jack Hopkins funding in 2021 were invited to participate in an anonymous online survey soliciting feedback on the grant process. Emails were sent on July 28, 2021 with a follow-up reminder sent on August 19th. 21 agencies responded, 85% of which received full funding in 2021 and 15% who received partial funding.


Question 1 - Agency Funding Requests

100% of agencies agreed that the criteria for funding provided was clear.




Question 3 - Comments on Jack Hopkins Criteria

- I believe the guidelines are clear and understandable
- All was clear
- I do appreciate JH allowing folks to apply for funding that is for operational costs but that don't meet the one-time exception rule. Staffing in particular is one of the most difficult needs to find funding for and many nonprofits scramble to make this work. I wonder if instead of making it something that is decided each year as something JH may or may not continue doing, JH limits requests for staff funding to every other year so nonprofits aren't doing it each year but they also don't have to wonder if it will be funded based on the one time exception rule or because JH decided not to do it that particular year. - This assistance was so needed for those struggling during this pandemic, plus the amount of money landlords of Sec. 8 housing are requiring is high. The guidance was quite clear.
- In discerning what we would like to apply for, the guidance provided made it very clear what we could NOT expect to be funded. By ruling out what could not be requested, we could hone in on what would work best for our agency given our current need.
- I've been working with these for over a decade and they seem understandable as to what your intent is.
- I feel like this allows the organization to make its case for funding whatever is needed most to make a broad and lasting impact on the community. I appreciate that it is not too precise and allows for flexibility based on need i.e. COVID, the flooding, etc. This structure allows for the largest needs to be met. I like the idea of one-time investment projects so that it is not just ongoing operating expenses, but requires people to be growing and doing new things to solve the problems they are addressing with their mission. I also like the emphasis on leveraging funds. I do think this grant helps leverage others in the community in an important way.
- My Sister's Closet's request for funding of \$22,456 to supplement the salary of an Assistant Store Manager is essential for our organization to continue in our ability to provide sufficient amounts of interview and job attire for clients coming to us for employment assistance. This service addresses a previously identified need in the community. It is extremely difficult for women heading single parent households to afford interview and work attire and essential hygiene products while competing to enter the job market. By providing these products, along with image consulting and interview skills training, MSC is able to help women living in poverty identify themselves as credible and professional job candidates. The result in greater job success and job retention with this demographic. This position was previously paid for in part with residual store sales and the free services of a regular community volunteer who stepped down in January 2020 with health issues. We were not able to count her 2019 volunteer hours in PPP loan requests and because our store sales were only 63% of 2019's sales, the position was not paid for in 2020. We plan to apply for larger Federal grants to help fund this position in the future. With the help of lack Hopkins Social Service Funding, the result will allow approximately 150 - 200 job seekers meet with greater success. The ultimate goal will give these clients the ability to compete for higher paying jobs with benefits that will allow them to spend more quality time with their children and provide them with better chance for life success.

90% of respondents heard of the Jack Hopkins funding program through email or word-of-mouth.




Question 5 - Comments on the Application Process

- It's not the application, but the process of having to get the agreement form notarized each year is a little cumbersome.
- I am wondering if there are other ways of allocating funding aside from the application process. Participatory grant-making is an idea that is gaining traction with many funders for example and I am sure there are other models. https://grantcraft.org/content-series/participatory-grantmaking/
- Please add a place for the statement of President and Officers, since some social service organizations do not have a local Executive Director or Board.
- It is very easy to follow. The biggest challenge is to keep within the work count.
- It was my first time applying. I was pleasantly surprised to discover that I was able to answer 95% of the questions. I needed some help with questions regarding financials from my vice-president, but otherwise, it was pretty easy. Having access to a well-written sample helped considerably.
- I think that the application has become very streamlined and easy to use/follow.
- Word count restrictions are very frustrating in these applications. Guidance on expected length of response is desired and appropriate, but something less restrictive would be nice.
- It is the most accessible grant application I work with. No duplication. Straightforward questions. Not overly or unnecessarily burdensome.
- We found the process to be simple! We did lose some time preparing slides, however, I understand that can change year to year and it didn't actually take a lot of time.
- It was very appreciated that the committee considered the unusual strains and pressure agencies have experienced while trying to help the community as a result of the pandemic. I know our organization was extremely grateful for the adjustment in the application and the assistance we have received. Many thanks to all committee members!

Question 7 - Comments on the Technical Assistance Meeting.

- We would like to learn more about agencies that have partnered on a Jack Hopkins project.



Question 9 - Comments on the Effectiveness of the Allocation Process

- Allow more exceptions for general operating expenses. Lots of funders want to fund new or one-time
 programs, few want to fund ongoing programs, and even fewer are willing to fund overhead costs, such as
 rent or accounting, which are incredibly vital to a well-run program.
- I do think there should be more transparency if someone on the committee works for, volunteers for or is heavily involved with a nonprofit that is presenting. Recusing themselves would be a great idea if applicable.
- I think this is one of the most sensible and impactful grant in which I've participated.
- Currently the system of determining who will receive funding and it what amount seems fair and unbiased. I feel confident that we were selected on merit and not out of any sort of loyalty from receiving the award in previous years.
- The larger amounts rewarded to fewer organizations is the most effective way to really meet community needs and I appreciate that Jack Hopkins chooses to do that.
- Are there times when local agencies have the same need, but don't know that another agency is applying for similar assistance? It might be the JHSS is in a unique position to suggest a shared solution or collaboration for both agencies in a more efficient way. By looking at the original applications, it might be possible to see a better solution in their behalf. Example: Two agencies need to hire a part-time staffer of 20 hours/week. Problem: Finding someone to work only 20 hours is more difficult than hiring a single person to work 40 hours. Suggested JHSS Solution: JHSS Committee suggests a meeting where it is proposed that both agencies work together to find one person who agrees to work 40 hours/week for both organizations in either a split schedule or simultaneously. Proposed Gain or Outcome: Could this result in a better, more productive solution? Would working in combination towards the same goal help both agencies out more than what they might have accomplished separately? Would there be greater retention of the employee? Would they be able to attract a smarter, more educated or experienced job candidate? There are several examples of how this might work, but not all organizations are going to know of potential collaborations or partnerships when writing their grant applications. However, after receiving the applications, the JHSS will and could potentially step up and make the suggestion

Question 11 - Comments on Leveraging Jack Hopkins Funds


- The equipment purchase through the Jack Hopkins award has allowed us to do work ourselves that we have typically needed a subcontractor for.
- The cooler allows us to make better use of grant and donation funds for produce. It lasts longer and allows us to use funds for other things.
- Yes, sharing with others who fund our non-profit that we have received a Jack Hopkins grant let's them know that they are investing into a good resource for our community.
- We are going to ask for funding from other sources for drug testing kits to match what JH gave us so I think this funding will help with attaining other funding for this project.
- We are in contact with many organizations/agencies, such as Monroe County United Ministries, Salvation Army, and our Trustees. The caseworkers and agency directors have been tremendously helpful in checking with SVdP concerning how we might assist their clients and vice versa.
- The funds will help us start a program that will benefit people and will help us bring in possible revenue to build and expand our services reach to the people we serve in the community.
- We will be able to produce more work to sell. The proceeds of our sales are in turn donated to non-profits in our community.
- The grant has made it much easier to fundraise because the community sees us as more "legitimate" now and we are bring in some partial matches of the grant.
- The funds we received most recently have allowed us to hire a new therapist to work with our Teen population. This therapist is very near his full license as a Social Worker, which will allow our agency to bill for his services through a broader range of insurance companies. These revenues impact our ability to pay the overhead for our agency for administrative efforts and building rent among many other needs required to keep our doors open. We also were able to request funding from another agency to purchase a laptop for the new therapist. Based on the fact that we received bridge funding to get the new therapist up and running while building his caseload from Jack Hopkins, we believe this influenced the other agency's desire to provide the additional aid of the laptop.
- I was able to acquire two additional grants in part because of IH's funding.
- Yes, certainly. There are many funders that look to see if the city or county are supporting a project or program before they get involved. They also look to see "big names" Cook, IU, etc. and Jack Hopkins has become a big name in funding in our community. People see that and feel like the organization, program or project is a worthy investment. I believe they trust the vetting process of the Jack Hopkins committee, so they believe that the investment for them is also a good one. We use the Jack Hopkins name on many things when we go solicit other funds in years that we receive the JH funding.
- We have several grants this year that are all going towards these programs. We have hundreds of volunteer
 hours going into our programs every year, these funds will help those hours go farther and have a bigger
 impact.
- Assuming the downtown market improves as the pandemic gets under better control, this funding will be supplemented by planned supporter (in-kind) donations and store sales from our Brick and Mortar and E-Commerce stores. So far, so good. Fingers crossed for a healthy Bloomington community!

Question 12 - Observations on the Collaborative Initiative

- COVID has made these potential collaborations more difficult from our lens
- I think collaboration is great and should be encouraged as long as the collaboration doesn't come about because one agency can't receive funding on their own for a specific project so manufacture a collaboration that didn't exist and perhaps won't exist after the funded project is over. I think if nonprofits work together to obtain funding for a project that benefits the community that is good for the community but nonprofits who have no plans for continuing the project after the funding period and are really just pretending to collaborate so an organization can acquire funding isn't good for the community or Jack Hopkins.
- While the idea is appealing for agencies that share similar goals, the challenges of administrative oversight would need to be overcome, such as report content, data entry and submission. We are supportive of the concept and will observe how those who are doing collaborative work proceed.
- Collaborations are of course something to strive for. They are a challenge to implement, but I applaud any organization that wishes to work with another for the good of the community.
- This year was not the year for us to be collaborative because of where our organization is in it's roll-out, but in the future we may want to do a collaborative project and would love to apply in this category.
- We are hopeful to one day receive a collaborative award with some of our community partners, specifically New Hope for Families. Although we did not receive funding for a joint CCB and New Hope collaboration, we will continue to look for the right project in line with the funding priorities of the Jack Hopkins Social Service Fund.
- Even in a collaboration, most likely one organization is doing one thing (their specialty) and another is doing something else (their specialty). Or one organization is doing something for another organization, like Catholic Charities providing counseling to Club kids in the Club instead of their office. Collaborations do not always provide efficiencies. However, they do allow organizations to specialize as opposed to try to be everything to everyone. If this funding was encouraged to be used more for contracting services with one another, that might be utilized more.
- I think it's a good idea. We don't have any plans to use that option currently, but I could see that working out well for us as our group has a lot of overlap with other groups in town.


Question 13 - Ideal Grant Distribution

- It is an incredibly valuable program to our community that fulfills a need that would otherwise be remain unmet.

- It can sometimes be difficult to complete a project on that condensed time frame, as we don't know if we will have funding for it, and then if it is only partially funded to have time to seek additional funding and then still complete the project.
- I think it is a bit confusing especially for first time applicants to realize the funding is not for a full year. JH is very gracious about extending the deadline so I think that works for folks but I think perhaps making it clearer in the grant application right up front that the grant doesn't span a full year would be helpful.
- Agencies whose work is handled by an all volunteer staff do not have employees. For such agencies it would be nice not to be required to provide an affirmative action plan or an e-Verify form.
- It is important to stress to each of you that the availability of these funds has most certainly enabled us to help so many more of those in need within our community and we are deeply grateful.
- Thank you for an effective and very reasonable process!
- My organization is grateful for your support. Jack Hopkins Social Services grants have become an important mainstay of our community. Thank you.
- I'd love a longer time frame to use the money (1 year would be ideal). It can be hard to be ready to spend money you don't know if you'll have that quickly, because if you don't get the grant, you'll be high and dry. The reimbursement component of this grant is also tricky (though not impossible) and should probably me more clearly advertised up front.

- Thank you for supporting our work in the community! We can't express our gratitude enough for the ways Jack Hopkins has helped us flourish, particularly during COVID when our demand skyrocketed. It truly felt like a lifesaver to know that Jack Hopkins funds had our back as we reconfigured our services.
- Having the funds reimbursement period be longer would be helpful although requests for extensions have been generous.
- We love this funding process and the way Jack Hopkins does things! Thank you for being a great funding partner to work with. It is beneficial to receive larger grant funds and to have such a clear application process with a smooth reporting and claims process. We really enjoy working with Jack Hopkins as a funder.
- We really appreciate how easy and straightforward this process is.
- This is the largest grant that we typically pursue, and I could see an even earlier cycle working even better for us, but this cycle works well.
- Many thanks to the JHSS Committee for the help My Sister's Closet has received over the years. This assistance has made an enormous difference in our ability to continue to serve those most vulnerable.

RESOLUTION 21-19

AUTHORIZING THE ALLOCATION OF THE JACK HOPKINS SOCIAL SERVICES PROGRAM FUNDS FOR THE YEAR 2021 AND RELATED MATTERS

- WHEREAS,
 the Common Council established the Social Services Funding Committee (Committee) in 1993 to make recommendations to the entire Common Council and Mayor regarding the allocation of discretionary social services funds and, in 2002, named the program in the honor of Jack Hopkins, who was instrumental as a Council member in the establishment of this funding program; and

 WHEREAS,
 pursuant to Resolution 02-16, as amended by Resolution 13-07, Resolution 16-06, and Resolution 20-09, the Committee serves as a standing committee of the Council with four members from the Council assigned by the President of the Council and with three City residents (appointed by the Committee Chair) with experience in social services; and
- WHEREAS, this year the Committee includes Council members Susan Sandberg (Chair), Ron Smith, Sue Sgambelluri, and Kate Rosenbarger along with City residents Tim Mayer, Mark Fraley, and Lauren McCalister; and
- WHEREAS, this year, the Committee has \$511,000 in budgeted funds to distribute; and
- WHEREAS, the Committee held an Organizational Meeting on March 2, 2021 to establish the program procedures for the year; and
- WHEREAS, at that time, the Committee affirmed its policies which set forth and elaborated upon the following criteria for making recommendations:

 1. The program should address a previously identified priority for social services funds (as
 - indicated in the Service Community Assessment of Needs (SCAN), the City of Bloomington Housing and Neighborhood Development Department's Consolidated Plan, or any other community-wide survey of social service needs); and
 - 2. The funds should provide a one-time investment that, through matching funds or other fiscal leveraging, makes a significant contribution to the program; and
 - 3. This investment in the program should lead to broad and long lasting benefits to the community; and
- WHEREAS, this affirmation included a 2012 change that allowed agencies to submit a second application as part of a collaborative project with one or more other agencies; and
- WHEREAS, this affirmation also included a change in 2016 that allowed agencies to submit requests for operational funding that did not meet one of the long-standing exceptions to the "one time funding requirement:" pilot projects, bridge funding, and collaborative projects; and
- WHEREAS, by the extended deadline at 5:00 p.m. on May 5, 2021 (an original deadline was established for May 2, 2021 but was extended due to it falling on a City of Bloomington Holiday), the Committee received 33 timely applications seeking approximately \$561,861.86 in funding; and
- WHEREAS, on April 20, 2021 the Committee met to discuss the applications, and, submitted written questions to agencies seeking additional information where needed; and
- WHEREAS, on April 29, 2021, select applicants gave presentations to the Committee electronically via Zoom; and
- WHEREAS, after receiving agency responses to the Committee's written questions and hearing the presentations, the members of the Committee evaluated proposals and assigned each proposal a recommended allocation; and
- WHEREAS, on May 11, 2021, the Committee met for a pre-allocation meeting and adopted a preliminary recommendation to fund 32 applications and these recommendations were adopted by the Committee at its Allocation Hearing on May 18, 2021; and
- WHEREAS, all the foregoing meetings were open to the public to attend, observe and record what transpired, and a period of public comment was offered before a vote on the recommendations was taken; and
- WHEREAS, funding agreements have or will be executed by the 32 agencies recommended to receive

funds, and those agencies understand and agree to abide by the terms of those agreements; and

WHEREAS, the staff of the HAND department will arrange for the disbursement of the grant funds pursuant to the funding agreements, which will be interpreted by the Chair of the Committee; and

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION 1. The Common Council now allocates Five Hundred Eleven Thousand Dollars (\$511,000.00) set aside for the Jack Hopkins Social Services Funding program to the following agencies for the following amounts and in accordance with the funding agreements approved in Section 2.

SECTION 2. The Council approves the funding agreements for these allocations, copies of which are kept in the Council Office and HAND department files, and directs the Office of the Controller to issue checks in the ordinary course of business to the agency once the staff of the Housing and Neighborhood Development Department submit a copy of the signed agreement and the appropriate purchase orders.

Jack Hopkins Social Services Funding Program

Elaboration of Criteria for Evaluating and Awarding Grants

In 1993 Jack Hopkins wrote a letter outlining a set of criteria for the use of these social services funds. Those criteria have since served as the basis for allocating the funds. The following is an elaboration of those criteria. These interpretations have been approved by the Jack Hopkins Social Services Committee.

Program Focus

The program should address a previously-identified priority for social services funds (as indicated in the Service Community Assessment of Needs (SCAN), the City of Bloomington Housing and Neighborhood Development Department's 2020-2024 Consolidated Plan, or any other community-wide survey of social service needs.)

This investment in the program should lead to broad and long lasting benefits to the community. Again, in the words of Jack Hopkins, "priority should be given to projects or programs where investments now will have a positive, long-term spillover effect (such as reduced susceptibility to ...diseases, decreased absences from school, reducing lost time (from work) ..., etc.)

Priorities

The Common Council prioritizes programs that provide food, housing, healthcare, or other services to city residents who are of low or moderate income, under 18-years of age, elderly, affected with a disability, or otherwise disadvantaged.

- I. <u>City Residency</u> Programs must primarily serve City residents. Individual programs have occasionally been located outside of the City but, in that case, funds have never been used for capital projects (e.g. construction, renovation, or improvement of buildings).
- II. <u>Low Income</u> Programs primarily serving low-income populations are given a high priority.
- III. <u>Emergency Services</u> Programs primarily providing emergency services (e.g. food, housing, and medical services) are given a high priority.

Scope of Funding

The Jack Hopkins Social Services Funding Program seeks to encourage innovation and address changing community needs. Further, the Jack Hopkins Social Services Funding Program recognizes that in the current economic climate, operational funding essential to a non-profit's continued provision of services is difficult to come by. The Jack Hopkins Social Services Funding Program will consider requests for both one-time investments and operational expenses.

One-Time Investment

Applications requesting funds for projects that address changing circumstances in the community are encouraged. Requests should provide a one-time investment that, through matching funds or other fiscal leveraging, make a significant contribution to the project. EXAMPLES – captital improvement etc.

Operational Expenses

Applications requesting operational expenses will also be considered. These expenses are recurring rather than non-recurring and examles typically include outlays for personnel, rent, utilities, maintenance, supplies, client services, and other ongoing budget items.

Paid Time Off and Bonuses

Paid time off and bonuses shall not be considered eligible for Jack Hopkins Social Services Funding.

Agencies seeking funding for operational expenses should be aware that future funding may be uavailable or inadequate to cover their needs and therefore they should not rely soley on Jack Hopkins Social Services Funding for their operational expenses. Any request for operational funding should be accompanied by a well-developed plan for future funding.

Fiscal Leveraging

In the words of Jack Hopkins, who originally proposed these criteria, investments "should be leveraged wherever possible by matching funds from other sources." Agencies may demonstrate such leveraging by using matching funds, working in partnership with other agencies, or through other means.

Applications from City Agencies and Other Property Tax Based Entities

Over the years the Council has not funded applications submitted by city departments. This is based on the theory that the departments have other, more appropriate avenues for requesting funds and should not compete against other agencies, which do not have the benefit of city resources at their disposal. Except on rare occasions, the Council has not directly or indirectly funded agencies that have the power to levy property taxes or whose primary revenues derive from property taxes.

Collaborative Projects

The Committee encourages social service agencies to collaborate in order to solve common problems and better address local social service needs. To serve these ends, the Committee will

allow agencies to submit an application for funding as a Collaborative Project in addition to submitting a standard application.

Collaborative Project Applicants

Applicants pursuing such funding should:

- I. Declare that they are seeking funds as a Collaborative Project and describe the project
- II. Describe each agency's mission, operations, and services, and how they do or will complement one another
- III. Describe the existing relationships between the agencies and how the level of communication and coordination will change as a result of the project
- IV. Identify challenges to the collaboration and set forth steps that address the greatest challenges to its success
- V. Address the following standard criteria and explain how the collaborative project will:
 - Serve a previously-recognized community need
 - Achieve fiscal leveraging or efficiencies
 - Provide a broad and long lasting benefits to the community
- VI. Complete a Memorandum of Understanding signed by authorized representatives of collaborating agencies and detailing the allocation of duties between them

Other Policies

Agency Acting as Fiscal Agent Must have 501(c) (3) Status

The agency that acts as the fiscal agent for the grant must be incorporated as a 501(c)(3) corporation. This policy is intended to assure that grant funds go to organizations:

- I. With boards who are legally accountable for implementing the funding agreements
- II. With the capability of raising matching funds which is an indicator of the long-term viability of the agency.

Given its mission, the presence of a board, and its general viability, an exception has historically been made for the Bloomington Housing Authority.

Funding of Events and Celebrations Discouraged

Historically the Council has not funded applications that promote or implement events or celebrations. This policy is based upon the conclusion that these occasions do not engender the broad and long-lasting effects required above.

One Application per Agency – Exception for Collaborative Projects

Except as noted below, each agency is limited to one application. This policy is intended to:

I. Spread funds among more agencies

- II. Assure the suitability and quality of applications by having the agency focus and risk their efforts on one application at a time
- III. Lower the administrative burden by reducing the number of applications of marginal value.

As noted above, an exception to this rule applies to agencies that submit an application as a Collaborative Project. Those agencies may also submit one other application that addresses the standard criteria.

Improvements to Real Property not Owned by the Applicant Agency is Discouraged

Applicants are advised that the Committee typically does not grant funds to agencies for capital improvements to real property not owned by the agency. Applications for construction, renovation, or improvements to a building not owned by the applicant agency will be given a low priority.

\$1,000 Minimum Dollar Amount for Request

This is a competitive funding program involving many hours on the part of staff and the committee members deliberating upon and monitoring proposals. The \$1,000 minimum amount was chosen as a good balance between the work expended and the benefits gained from awarding these small grants.

Funding Agreement - Reimbursement of Funds


Agencies that are granted funds will be expected to enter into a funding agreement with the City of Bloomington. The Housing and Neighborhood Development (HAND) Department has been monitoring funding agreements since 2001. In order to be consistent with the practices it employs in monitoring CDBG and other funding programs, the funding agreements provide for a reimbursement of funds. Rather than receiving the funds before performing the work, agencies either perform the work and seek reimbursement, or enter into the obligation and submit a request for the city to pay for it.

Expenditure Before the End of the Year

In order to avoid having the City unnecessarily encumber funds, agencies should plan to expend and verify these grants before December of the year the grant is awarded, unless specifically approved in the funding agreement or granted an extension by the Director of HAND. Please note that funds encumbered from one calendar year to the next cannot be reimbursed by use of the City's credit cards.

Proportionality of Funding Request Relative to Clients Served

In making funding decisions, the Committee may consider the amount of funding requested relative to the number of clients that would be served by a given project.

Dear Social Services Agency:

The City of Bloomington Common Council's Jack Hopkins Social Services Committee invites social services agencies serving the needs of City of Bloomington residents to apply for 2022 grant funding. This year, the Committee has \$317,000 (plus possible reverted funds) to distribute. Each year, the Mayor and City Council have allocated funding for the Jack Hopkins initiative. In fact, since 1993, the Jack Hopkins Committee has granted approximately \$5.5 million to social service agencies who serve our community's most vulnerable residents.

As funding for the Jack Hopkins program has increased over the years, so too has our responsibility to be good stewards of this fund – a fund enabled by City of Bloomington taxpayer dollars. As stewards of these dollars, we strive to fund projects that have the potential for lasting change -- projects that will improve the human condition of Bloomington residents in the long run. Please be advised that, depending on the strength of the applicant pool, the Committee may not distribute all of its available funding.

Changes in 2022

The Jack Hopkins Committee has implemented a few notable changes for 2022.

1) Operational Funding Requests

In recognition of the growing need for operational funds, the Jack Hopkins Committee has elected to begin accepting requests for operational funding. Any request for operational funds should be accompanied by a well-developed plan for future funding.

2) <u>Limitation Added for Use of Funds</u>

Jack Hopkins Social Services Funds that are awarded for personnel expenses can no longer be used toward paid time off and bonuses.

3) New Budget Worksheet

4) Limitation added to Claims Submission Dates

Claims will only be considered for expenses incurred after the date that the Common Council appropriates the Jack Hopkins funds (in mid-June) unless previously approved by the Committee.

Proposal Must Meet the Following Criteria:

1) Address a Previously-Identified Priority for Social Services Funding.

The need should be documented in the <u>Service Community Assessment of Needs (SCAN)</u>, City of Bloomington, Housing and Neighborhood Development Department's <u>Consolidated Plan</u> or any other community-wide survey of social service needs. High funding priorities include emergency services (food, shelter or healthcare) or other support services to City residents who are: low-moderate income, under 18-years old, elderly, affected with a disability, or are otherwise disadvantaged.

2) Scope of Funding

- a. <u>One-Time Investment.</u> One Time Investment Applications requesting funds for projects that address changing circumstances in the community are encouraged. Requests should provide a one-time investment that, through matching funds or other fiscal leveraging, make a significant contribution to the project.
- b. <u>Operational Expenses</u> Applications requesting operational expenses will also be considered. These expenses are recurring rather than non-recurring and examples typically include outlays for personnel, rent, utilities, maintenance, supplies, client services, and other ongoing budget items. It is worth noting that paid time off and bonuses are not eligible for Jack Hopkins Social Services Funding.

3) Leverage Matching Funds or Other Fiscal Mechanisms.

Other fiscal mechanisms might include things like number of volunteers or volunteer hours devoted to the proposed project, working in partnership with another agency, and/or other in-kind donations.

4) Make a Broad and Long-Lasting Contribution To Our Community.

As articulated by Jack Hopkins, the co-founder of this program: "[P]riority should be given to projects or programs where investments now will have a positive, long-term spillover effect (such as reduced susceptibility to...diseases, decreased absences from school, reducing lost time from work, [alleviating the effects of poverty]...etc.)." Historically, this criterion has excluded funding for events or celebrations.

Collaborative Projects - Two Applications Allowed

The Committee continues to accept applications for collaborative projects that address community-wide social problems and more efficiently meet the needs of social service agencies and agency clients. Note that if you are submitting a collaborative application, you may submit two applications – an individual application on behalf of your agency and another as part of your collaborative proposal. If submitting an application for a collaborative project, applicants must include a Memorandum of Understanding (MOU).

Elaboration of Criteria

Over time, the Committee has refined each criterion. A detailed explanation of criteria is provided in the Committee's *Elaboration of Criteria*, posted on the Committee's webpage https://bloomington.in.gov/council/jack-hopkins. Agencies are strongly encouraged to review this document.

Other Requirements

In addition to satisfying the Jack Hopkins criteria, to be eligible for funding an application must meet the following requirements:

- Hopkins funds are intended to be put to work in the community as soon as possible. For that reason, agencies must submit final claims no later than <u>December 9, 2022.</u>
- The program for which funding is sought *must primarily benefit City residents*.
- The application must request a minimum of \$1,000.
- The applicant must be a 501(c)(3), or be sponsored by one. In the event the applicant is sponsored by a 501(c)(3), the sponsoring agency must provide a letter acknowledging its fiscal relationship to the applicant. All new applicants are required to submit 501(c)(3) documentation.
- One application per agency, unless participating in a collaborative project.
- Any agency receiving Jack Hopkins funds must participate in the federal <u>E-Verify</u> program.

Living Wage Requirements

Some not-for-profit agencies receiving Jack Hopkins Funds are subject to the City's Living Wage Ordinance, *Bloomington Municipal Code* §2.28. For 2022, the Living Wage is \$14.01 an hour, of which \$2.10 may be in form of health insurance to the covered employee.

An agency is subject to the Living Wage Ordinance, **only if all three** of the following are true:

- 1. The agency has at least 15 employees; and
- 2. The agency receives \$25,000 or more in assistance from the City in the same calendar year; and
- 3. At least \$25,000 of the funds received are for the operation of a social services program, not for physical improvements.

An agency who meets all three criteria is not obligated to pay the full amount of the living wage in the first two years they received assistance from the City; instead they are subject to a phase-in requirement. Please visit *Living Wage FAQs for Non-Profits* to learn more.

How to Apply

To be eligible for consideration, your agency **must** submit the following. Applications that are missing any of the required information will be eliminated from further consideration.

- ✓ **COMPLETED APPLICATION FORM**. Electronic forms are available at: https://bloomington.in.gov/council/jack-hopkins (Return as a PDF)
- ✓ **PROJECT BUDGET DETAILING THE USE OF HOPKINS FUNDS** (<u>Please Note:</u> this is a detailed accounting of how Jack Hopkins dollars would be spent on the project proposed in the application, not the budget for the organization)
- ✓ **APPLICATION SUMMARY** (Return as a Word Document)
- ✓ A YEAR-END FINANCIAL STATEMENT including fund balances, total revenue and expenditures
- ✓ **SIGNED, WRITTEN ESTIMATES** if seeking funding for equipment or capital improvements
- ✓ A MEMORANDUM OF UNDERSTANDING signed by all agencies participating in an application for a Collaborative Project
- ✓ **501(c)(3) DOCUMENTATION FOR ANY FIRST-TIME HOPKINS APPLICANT**Agencies who have previously applied from Jack Hopkins funding do not need to provide this documentation.

FUNDING AGREEMENT CITY OF BLOOMINGTON - JACK HOPKINS SOCIAL SERVICES PROGRAM

«Organization»

This Agreement entered into in June 2022 by and between the City of Bloomington, Indiana hereinafter referred to as the "City," and «Organization», hereinafter referred to as the "Agency," provides for the following:

Whereas, the Jack Hopkins Social Services Program Committee (Committee) reviewed Agency applications, considered additional information provided by agencies in response to Committee questions, and made funding recommendations to the Common Council;

Whereas, the Common Council adopted Resolution 22-xx which provided funding to this Agency in the amount and for the purposes set forth in Sections I and III of this Agreement;

Whereas, the resolution also delegated the duty of interpreting the Funding Agreement for the City to the Chair of the Committee; and

Whereas, in interpreting the Agreement, the Chair may consider the purposes of the program, the application and comments by Agency representatives, and statements made by decision-makers during deliberations.

NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

I. USE OF FUNDS

These funds are intended to serve vulnerable City residents. Agency agrees to use Agreement funds as follows:

II. LIMITATIONS ON FUNDS.

- Expenditures incurred prior to the execution of this Agreement shall not be considered eligible for Jack Hopkins Social Services Funding.
- Paid time off and bonuses shall not be considered eligible for Jack Hopkins Social Services Funding. Agencies receiving funding for operational expenses acknowledge that future funding may be unavailable or inadequate to cover their needs and that they should not rely solely on Jack Hopkins Social Services Funding for their future operational expenses.

III. TIME OF PERFORMANCE

- The last claim for expenses under this Agreement must be submitted to the City of Bloomington Housing and Neighborhood Development (HAND) no later than <u>December</u> 09, 2022.
- Requests for extensions must be submitted in writing to HAND's Director no later than November 18, 2022.
- If an extension is approved, the Director will provide a confirmation letter granting the extension for claim submission. The deadline will be no later than March 24, 2023.

IV. PAYMENT PROCEDURES

It is expressly agreed and understood that the total amount to be paid by the City under this Agreement shall not exceed

Claims for the payment of eligible expenses shall be made against the items specified in Section I, Use of Funds.

The Agency will submit to the City a claim voucher pursuant to City's claim procedures and deadlines for the expenditures corresponding to the agreed upon use of funds outlined above. Along with the claim voucher, the Agency will submit documentation satisfactory to the City, at the City's sole discretion, showing the Agency's expenditures.

V. ADMINISTRATIVE REQUIREMENTS

A. Accounting Procedures

The Agency agrees to use generally accepted accounting procedures and to provide for:

- (1) Accurate, current, and complete disclosure of the financial component of its activities;
- (2) Records which identify adequately the source and application of funds for City supported activities;
- (3) Effective control over and accountability for all funds, property, and other assets;
- (4) Adequate safeguarding of all such assets and assurance that they are used solely for authorized purposes;
- (5) The City to conduct monitoring activities as it deems reasonably necessary to insure compliance with this Agreement; and
- (6) Return of the funds received under this Agreement that the City determines were not expended in compliance with its terms.

B. Access to Records

The Agency agrees that it will give the City, through any authorized representative, access to, and the right to examine, all records, books, papers or documents related to the funding provided

by this Agreement, for the purpose of making surveys, audits, examinations, excerpts, and transcripts.

C. Retention of Records

The Agency agrees that it will retain financial records, supporting documents, statistical records, and all other records pertinent to the funding provided to the Agency for a period of three years from the termination of this Agreement pursuant to Section VII or VIII.

D. Reporting Requirement

The Agency agrees to provide a report to HAND with the Agency's last claim submission describing the use of Jack Hopkins Social Services funds. The report should be submitted in Word format and not exceed 500 words. The report should include, but not be limited to:

- 1. Amount of the agency's grant award
- 2. General description of the project
- 3. Results of the project as measured by the project's outcome indicators
- 4. Population served by the program
- 5. Community benefits of the project
- 6. Digital photograph(s) depicting the Jack Hopkins-funded project
- 7. Documentation of any written material for the project giving the Jack Hopkins Social Services Funding Committee credit as required by V(G) below.

Agencies are asked to report the results of their project concisely and to include both successes and challenges. The report shall be submitted no later than <u>December 9, 2022</u> unless the Agency was granted an extension by the HAND Director, pursuant to Section II of this agreement.

Agencies who receive **operational funding** under this Agreement shall submit an additional report providing an update on the project's outcome indicators, as outlined in the agency's application for funding, due <u>March 29, 2023</u>.

NOTE: Operational expenses are those that are recurring and include outlays for personnel, rent, utilities, maintenance, supplies, client services, and other like ongoing budget items.

VI. GENERAL CONDITIONS

A. General Compliance

Agency agrees to comply with all applicable federal, State, and local laws, regulations, and policies governing the funds provided under this contract.

B. <u>Independent Contractor</u>

Nothing contained in this Agreement is intended to, or shall be construed in any manner, as creating or establishing the relationship of employer/employee between the parties. The Agency shall at all times remain an "independent contractor" with respect to the services to be performed under this Agreement. None of the benefits provided by an employer to an employee, including but not limited to minimum wage and overtime compensation, workers' compensation insurance and unemployment insurance, shall be available from or through the City to the Agency.

C. Hold Harmless

The Agency shall hold harmless, defend and indemnify the City from any and all claims, actions, suits, charges and judgments whatsoever that arise out of a subrecipient's performance or nonperformance of the services or subject matter called for in this Agreement.

D. Nondiscrimination (for agencies receiving grants in excess of \$10,000)

Agencies receiving grants in excess of Ten Thousand Dollars (\$10,000) shall be subject to Section 2.21.000 et seq. of the Bloomington Municipal Code. Unless specific exemptions apply, the Agency will not discriminate against any employee or applicant for employment because of race, color, religion, ancestry, national origin, sex, disability, sexual orientation or gender identity. The Agency will take affirmative action to insure that all employment practices are free from such discrimination. Such employment practices include but are not limited to the following: hiring, upgrading, demotion, transfer, recruitment or recruitment advertising, layoff, termination, rates of pay or other forms of compensation, and selection for training, including apprenticeship. The Agency agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided by the City setting forth the provisions of this nondiscrimination clause.

E. Living Wage Requirements

- (1) This agreement is subject to the City of Bloomington Living Wage Ordinance, Chapter 2.28 of the Bloomington Municipal Code and any implementing regulations. The Living Wage Ordinance requires among other things, that unless specific exemptions apply, all beneficiaries of City subsidies, as defined, shall provide payment of a minimum level of compensation to employees which may include the cost of health benefits. Such rate shall be adjusted annually pursuant to the terms of the Bloomington Living Wage Ordinance.
- (2) Under the provisions of the Bloomington Living Wage Ordinance, the City shall have the authority, under appropriate circumstances, to terminate this contract and to seek other remedies as set forth therein, for violations of the Ordinance.

F. Compliance with IC 22-5-1.7 – E-Verify Program

Agency shall sign a sworn affidavit, attached as Exhibit A, affirming that the Agency has

enrolled and is participating in the E-Verify Program and affirming that the Agency does not knowingly employ an unauthorized alien. Agency must provide documentation to the City that Agency has enrolled and is participating in the E-Verify program.

G. <u>Jack Hopkins Social Services Committee Recognition</u>

The Agency agrees to provide a credit line for the City of Bloomington Common Council Jack Hopkins Social Services Committee in all written materials about the program activities funded pursuant to this Agreement.

VIII. TERMINATION OF AGREEMENT

The Agency agrees that this Agreement is subject to the availability of funds and that if funds become unavailable for the performance of this Agreement, the City may terminate the Agreement. If funds become unavailable, the City shall promptly notify the Agency in writing of the termination and the effective date thereof.

It is further agreed that the City may terminate this Agreement in whole or in part if it determines that the Agency has failed to comply with the Agreement or with other conditions imposed by applicable laws, rules and regulations. The City shall promptly notify the Agency in writing of the determination and the reasons for the determination, together with the effective date. The Agency agrees that if the City terminates the Agreement for cause it will refund to the City that portion of the funds that the City determines was not expended in compliance with the Agreement. The Agency shall be responsible for paying any costs incurred by the City to collect the refund, including court costs and reasonable attorneys' fees.

If any provision of this Agreement is held invalid, the remainder of the Agreement shall not be affected thereby, and all other parts of this Agreement shall nevertheless be in full force and effect.

IX. TERM OF AGREEMENT

Unless terminated as provided in Section VII herein, this Agreement shall terminate upon the City's determination that the provisions of this Agreement regarding use of the Agreement funds have been met by the Agency.

Common Council Jack Hopkins Social Services Committee Accepting Applications for the 2022 Funding Cycle

Bloomington, IN – The City of Bloomington Common Council's Jack Hopkins Social Services Committee invites social services agencies serving the needs of City of Bloomington residents to apply for 2022 grant funding. This year, the Committee has \$317,000 to distribute. Applications are available at the Committee's webpage https://bloomington.in.gov/council/jack-hopkins. Applications are due by **Friday, 1 April 2022 no later than 4:00 pm.**

Named in honor of former Council member Jack Hopkins who helped establish the program in 1993, the program is dedicated to funding projects that improve the lives of the City's most vulnerable residents. Vulnerable residents include those who are low-to-moderate income, under 18 years of age, elderly, people with a disability, or otherwise disadvantaged. Since the program's inception, the City has allocated over \$5.5 million to local social service agencies.

The Committee is composed of four members of the Bloomington Common Council and three City residents with experience in social services. Council members serving are: Susan Sandberg (Chair), Matt Flaherty, Jim Sims, and Ron Smith. The citizen appointments are: Tim Mayer, Mark Fraley and Lauren McCalister.

Committee Chair Susan Sandberg advises that "[t]he Committee thoroughly considers each application for probability of success and maximum impact so that tax dollars are spent efficiently and effectively."

In recognition of the growing need for operational funds, the Jack Hopkins Committee has elected to change the funding criteria to include the acceptance of operational funding requests. Any request for operational funds should be accompanied by a well-developed plan for future funding.

Criteria

In general, applications must meet the following criteria:

- The program should address a previously-identified priority for social services funds (as indicated in the SCAN Report, City's Housing and Neighborhood Development department's Consolidated Plan, or other community-wide survey of social service needs);
- The funds should provide a one-time investment that, through matching funds or other fiscal leveraging, makes a significant contribution to the program;
- This investment in the program should lead to broad and long-lasting benefits to the community.
