  - i. His report was discussed under the Outstanding Black Leaders and Tomorrow and the Black Male Youth Summit portions of the agenda.

  - i. James mentioned tabling the event

Dhakir reported that the event was on and was to be held on August 6<sup>th</sup>, 2025. He thanked Cornellius for reaching out to the Principal of Fairview to confirm the event was fine to proceed as it had in past. Dhakir thanked Andrew for his and his interns help in confirming with the principal that the event was fine to proceed as it had in the past by visiting Fairview and talking with the principal's assistant leaving flyers and emailing the principal

- d. Black Male Youth Summit
  - i. James reported that given that the approaching deadline that the CSBM should put forward different speakers relating to the themes of the event and to subsequently collect their bios and such. It was stated that we should allow the speakers to choose a theme from those selected to speak to. James mentioned that he had one speaker in mind and would confirm with him if he could speak at the event.

Dhakir-discussed how he had reserved tickets with the Indiana Civil Rights Commission through the direction of Virgil Giles, the then Director of the Indian Chapter of the Indiana Commission on the Status of Black Males. However, after calling Dhakir onetime but missing him and leaving a message Dhakir could not get back in touch with them to claim the tickets. Dhakir was never called back by the Civil Rights Commission despite the different times he called. Nor could he get in touch with Virgil by calling his office or emailing him.
- b. Patrick—wanted to know why the Office of the Mayor wished the Bloomington Commissions to turn back in their name tags. Andrew responded that said Office was hoping to establish uniformity.
