I. Discrimination Complaints

- A. Pending from previous quarters

 - a. Woman filed complaint alleging discrimination in employment on the basis of disability in July, 2023

- C. Complaints filed with other jurisdictions
 - 1. No Assigned Commissioner—conflict of interest
 - a. Man filed complain against property manager on the basis of disability (this actually took place in June, 2023). Transferred to EEOC

II. Miscellaneous Inquiries

- A. Columbus Human Rights Commission called to discuss possible labor trafficking from Columbus to Bloomington. Referred her to National Labor Trafficking hotline or IPATH.
- B. Anonymous report was made regarding a rental company without indication of discrimination. No action was taken.
- C. Individual, a woman, complained of disability discrimination due to a lack of accommodations for the remodeling of her apartment. Discussed ways to approach management regarding the issue.
- D. Individual, a woman, called to report suspicions of discrimination against a neighbor. Referred her to local law enforcement.

- E. Individual, a woman, complained of disability discrimination due to a lack of wheelchair accessible access to the laundry room at her residence. Referral pending.
- F. Individual, a woman, called numerous times regarding general complaints, though the type of discrimination isn't clear. Referred her to the BMCHRC intake form and the Human Rights Ordinance.
- G. Individual called to report potential wage discrimination at a restaurant on behalf of a friend. Referred caller to Indiana's Department of Labor Wage and Hour Division or Indiana Legal Services.
- H. Couple complained of sexual orientation discrimination after not receiving a refund at a hotel. Requested more information and documentation of the interaction.
- Individual, a minor, called to report sexual orientation discrimination at a Christian school after being kicked out due to the school believing he was gay. Suggested further conversation to determine if a case should be filed.
- J. Individual, a man, called to report racial discrimination in employment after coworkers and supervisors were using racial slurs. Set up an intake before realizing the caller is in Bloomington, Minnesota.
- K. Individual, a woman, called to complain of a lack of handicap accessible parking and entrances at two separate establishments. Director will investigate the issue.
- L. Individual, a man, called to complain of a landlord making him pay a deposit on his emotional support animal. Found statute to support the caller's complaint and spoke with landlord. Caller will call back if communication breaks down.
- M. Individual, a woman, called to complain of a post-secondary school reducing the amount of credit hours she receives when she is late due to caring for her disabled daughter. Referred her to Terre Haute Human Relations Commission.
