Amendment text: Pg. 42, under the heading "Food & Agriculture":

Add after the first sentence:

The Food Charter recognizes that food security is a basic human right; that collaborations among local government, businesses, and community groups should take place to support a sustainable, well-functioning local food system; that urban agriculture should be supported, including farming, community gardens, rooftop and home gardens, orchards, and edible landscaping; and that local food processing and marketing should be facilitated and not hindered by local regulations.

Start a new paragraph with "Residents have constitently demonstrated..."

Justification: Remove redundancy in text about food and agriculture while recognizing the role of the Food Policy Council.

Amendment text:

Page 42, under heading "Food & Agriculture." Text revision in new Paragraph 2: <u>Current:</u> Residents have consistently demonstrated an interest in the economic, social, and health inssues connected to local food access. These interconnections relate to impacts on the environment, to health, to food access, food equity, and food security.

<u>New:</u> Residents have consistently demonstrated an interest in the economic, social, and health inssues connected to local food access. These concerns have found expression through the Bloomington Food Policy Council and relate to the three E's of sustainability: environmental impact, equity of access to food, and economic impact of local food production and processing.

Current: Balance public investments in infrastructure and technology to support a robust economy and to enhance Downtown Bnloomington's status as a regional economic and tourist center.

New: Ensure that public investments in infrastructure and technology do not detract from historic preservation and pedestrian-friendly character in the downtown.

Adding an architect would professionalize the architectural design review, which is outside the primary expertise of professional planners and elected representatives.

Brief synopsis/justification for Amendment:

The existing downtown guidelines are already primarily a form based code, with design guidelines adopted from the 2005 Downtown Infill Strategy Plan. Language in the original plan allows for modern design as well. * The 2005 guidelines were developed to help achieve the community goal of compatible infill design.

Indiana University values compatible form in their immediate campus and that was the goal of the community driven Downtown Plan that our current overlay districts are based on. There are differing guidelines for the different districts.

There is nothing magic about form based codes. These can get things dramatically wrong as well as right, based on complex guidelines or the lack of them. The new directive and a carelessly written form based code could allow incompatible design by right and could leave out critical requirements like the one for commercial use on the ground floor, a basic concept for building a long term sustainable and viable downtown. The current language is dangerously vague.

We should revise our guidlelines carefully and not abandon the community vision of a cohesive and compatible downtown. We should continue to reference and update the long range community document that is our Downtown Plan. Maintaining and enhancing community character is tied to our economic development.

<u>Existing Program Page 51:</u> Update and revise Downtown overlay districts with form based code building forms and massing that relate to the street and pedestrian, whether through traditional architectural forms or innovative new designs.

Proposed Amendment:

Add: ""new designs. Compatible architectural guidelines and materials shall be included in guidelines that are specific to each of the downtown districts using an updated 2005 Downtown Plan for guiding design principles. Commercial on the first floor shall be maintained in the appropriate districts. Form based code shall be extended into traditional neighborhoods that are not historic districts. Code should be revised using urban consultants with experience in creating form based code specifically."
