Welcome to the City of Bloomington public hearing regarding the proposed project to improve the intersection of Tapp Road and Rockport Road. The proposed project will provide a new traffic signal at the intersection of Tapp Road and Rockport Road. The proposed project will also include intersection sight distance improvements, correction of the substandard sight distance on the west leg of Tapp Road, addition of left turn lanes along Tapp Road, placement of curb and gutter, storm sewer and appurtenant structures and signs. No business or residential relocations are proposed. The intersection will be closed to traffic during construction and appropriate signs will be installed for traffic detour.







Tapp Road (West Leg)







Country Club Road with Retaining Wall (East Leg)
